THE NORFOLK COUNTY COUNCIL (LONG STRATTON, B1527 HEMPNALL ROAD AND C497 BUNGAY ROAD) (PROHIBITION OF DRIVING) ORDER 2020

The Norfolk County Council in exercise of their powers under Sections 1(1) 2(1) to (3) and 3(2) and 122 and parts III and IV of Schedule 9 of the Road Traffic Regulation Act 1984 (hereinafter referred to as "the Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby make the following Order:

- 1. This Order may be cited as The Norfolk County Council (Long Stratton, B1527 Hempnall Road and C497 Bungay Road) (Prohibition of Driving) Order 2020 and shall come into operation for all purposes on the 2nd day of November 2020.
- 2. Save as provided in Article 3, no person shall, except upon the direction of, or with the permission of a police constable in uniform or of a Civil Enforcement Officer, cause any vehicle to proceed along the lengths of roads specified in the Schedule to this Order.
- 3. Nothing in Article 2 of this Order shall apply so as to prevent any person from causing a vehicle to proceed in the lengths of road specified in that Article if the vehicle is being used:
 - (a) for fire brigade, police or ambulance purposes;
 - (b) in the service of a local authority or water authority in pursuance of statutory powers or duties;
 - (c) is in connection with the maintenance, improvement or reconstruction of that length of road or the laying, erection, alteration or repair in or adjacent to that length of road of any sewer, water, gas, or electricity apparatus or of any electronic communications apparatus as defined in the Communications Act 2003; or
 - (d) by the local highway authority or its contractors:-
 - (i) for the purpose of maintenance of equipment situated on northeastern side of the length of road formerly known as the A140 Norwich Road from its junction with the B1527 Hemphall Road for a distance of 75 metres north-eastwards; and
 - (ii) to access the area of natural regeneration from a point along the C497 Bungay Road 58 metres northwest of the centreline of its junction with the new A140 Norwich Road roundabout.
- 4. Insofar as any provision of this Order conflicts with any provision of any previous Order relating to the lengths of road specified in the Schedule to this Order, that provision of this Order shall prevail.

Prohibition of Driving - At Any time

C497 Bungay Road North Side	-	From a point 58 metres northwest of the centreline of its junction with the A140 Norwich Road roundabout north-eastwards for a distance of 19 metres extending south-eastwards to the western boundary of the A140 Norwich Road and extending northwestwards for a distance of 107 metres.
B1527 Hempnall Road North Side	-	From a point 17 metres south-east of the centreline of its junction with the A140 Norwich Road roundabout northwards for a distance of 199 metres extending westwards to the eastern boundary of the A140 Norwich Road and extending south-eastwards to the western boundary of the Public Right of Way Long Stratton FP1.
		From its junction with the Public Right of Way southeastwards for a distance of 146 metres.
B1527 Hempnall Road South Side	-	From a point 17 metres south-east of the centreline of its junction with the A140 Norwich Road roundabout southwards for a distance of 246 metres.
