# THE NORFOLK COUNTY COUNCIL (ROYDON, MANOR ROAD, OLD HIGH ROAD) (PROHIBITION OF WAITING, SCHOOL KEEP CLEARWAY) AMENDMENT ORDER 2020

The Norfolk County Council in exercise of their powers under Sections 1(1), 2(1), 2(2) and 4(2) and 122 and Parts III and IV of Schedule 9 of the Road Traffic Regulation Act 1984 and the Traffic Management Act 2004 and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby make the following Order:-

- 1. This Order may be cited as the "The Norfolk County Council (Roydon, Manor Road, Old High Road) (Prohibition of Waiting, School Keep Clearway) Amendment Order 2020 and shall come into effect for all purposes on the 31st day of August 2020.
- 2. The Norfolk County Council (Roydon, Various Roads) (Prohibition of Waiting) Consolidation and Variation Order 2011 (hereinafter referred to as "the 2011 Order") is amended as set out in Articles 3 and 4 of this Order.
- 3. Schedule 1 of the 2011 Order is amended by the deletion and addition of the lengths of roads as specified in the Schedule 1 to this Order.
- 4. The following paragraph is added as Article 3(A)
  - "3(A) Save as provided in Article 4 of this Order no person shall, except upon the direction or with the permission of a police constable in uniform or of a Civil Enforcement Officer, cause or permit any vehicle to wait at any time along the school keep clear markings in the area of carriageway specified in Schedule 2 of this Order which is comprised within and indicated by a road marking complying with diagram 1027.1 in Schedule 7 to The Traffic Signs Regulations and General Directions 2016.
- 5. Insofar as any provision of this Order conflicts with any provision of any previous Order relating to the lengths of road specified in the Schedule to this Order, that provision of this Order shall prevail.
