

**THE NORFOLK COUNTY COUNCIL  
(THORPE ST ANDREW, VARIOUS ROADS) (PROHIBITION OF WAITING)  
TRAFFIC REGULATION AMENDMENT ORDER 2020**

The Norfolk County Council in exercise of their powers under Sections 1(1), 2(1), 2(2) and 4 and 122 and Parts III and IV of Schedule 9 of the Road Traffic Regulation Act 1984 (hereinafter referred to as "the Act") and the Traffic Management Act 2004 and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby make the following Order:-

1. This Order may be cited as the Norfolk County Council (Thorpe St Andrew, Various Roads) (Prohibition of Waiting) Traffic Regulation Amendment Order 2019 and shall come into effect for all purposes on the 7<sup>th</sup> September 2020.
2. The Norfolk County Council (Thorpe St Andrew, Various Roads) (Prohibition of Waiting) Consolidation and Variation Order 2011 (hereinafter referred to as the "2011 Order") is amended by the addition of the lengths of roads as specified in the Schedule to this Order.
3. Insofar as any provision of this Order conflicts with any provision of any previous Order relating to the lengths of road specified in the Schedule to this Order, that provision of this Order shall prevail.

**SCHEDULE**  
**In the Town of Thorpe St. Andrew**

**Prohibition of Waiting At Any Time**

U59559 Laundry Lane Slip Road (North side)	-	For its entire length.
A1042 Saint Williams Way/Ring Road (South side)	-	From a point 82 metres northwest of the centreline of the U59595 Thor Loke south-eastwards to a point 12 metres southeast of the centreline of the U59559 Laundry Lane.
A1042 Saint Williams Way/Ring Road (North side)	-	From a point 82 metres northwest of the centreline of the U59595 Thor Loke south-eastwards to its junction with the U59559 Laundry Lane.
U59595 Thor Loke (Both Sides)	-	From its junction with the A1042 Saint Williams Way southwards for a distance of 15 metres.
U59585 Thorpe Avenue (Both sides)	-	From its junction with the A1042 Ring Road northwards for a distance of 10 metres.
