THE NORFOLK COUNTY COUNCIL (NEWTON FLOTMAN, FLORDON ROAD) (PROHIBITION OF WAITING) AMENDMENT ORDER 2021

The Norfolk County Council in exercise of their powers under Sections 1(1), 2(1), 2(2) and 4(2) and 122 and Parts III and IV of Schedule 9 of the Road Traffic Regulation Act 1984 (hereinafter referred to as "the 1984 Act") and the Traffic Management Act 2004 and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the 1984 Act hereby make the following Order:-

- 1. This Order may be cited as The Norfolk County Council (Newton Flotman, Flordon Road) (Prohibition of Waiting) Amendment Order 2021 and shall come into operation for all purposes on the 25th day of January 2021.
- 2. The Norfolk County Council (Newton Flotman, Flordon Road, St Marys Close) (Prohibition of Waiting) Order 2019 (hereinafter referred to as "the 2019 Order") is amended as set out in the Schedules to this Order.
- 3. No person shall, except upon the direction or with the permission of a police constable in uniform or of a Civil Enforcement Officer, cause or permit any vehicle to wait at any time along the lengths of road specified in Schedule 2 to this Order.
- 4. Insofar as any provision of this Order conflicts with any provision of any previous Order relating to the lengths of road specified in the Schedule to this Order, that provision of this Order shall prevail.
