THE NORFOLK COUNTY COUNCIL (NORWICH, BUS STOP CLEARWAYS) (AYLSHAM ROAD) AMENDMENT TRAFFIC REGULATION ORDER 2021.

The Norfolk County Council in exercise of powers under sections 1, 2, 4 and 122 and Parts III and IV of Schedule 9 of the Road Traffic Regulation Act 1984, (hereinafter referred to as "the Act") and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby make the following Order:-

1. <u>Citation and Commencement</u>

This Order may be cited as The Norfolk County Council (Norwich, Bus Stop Clearways) (Aylsham Road) Amendment Traffic Regulation Order 2021 and shall come into effect for all purposes on the 29th day of November 2021.

- 2. The Norwich City Council (Bus Stop Clearways) (Aylsham Road, Earlham Road, Magpie Road, Sprowston Road) Traffic Regulation Order 1997 (hereinafter referred to as the "1997 Order") is amended as specified in Article 3 of this Order.
- 3. References to Aylsham Road in Schedule 1 of the 1997 Order are amended as set out in Schedule 1 of this Order.
- 4. Insofar as any provision of this Order conflicts with any provision of any previous Order relating to the lengths of road specified in the Schedules to this Order, that provision of this Order shall prevail.

Delete the following references:

A140 Aylsham Road (East Side)	-	(h) From a point 15m south of its junction with Suckling Avenue to a point 33m north of its junction with Baxter Court.
A140 Aylsham Road (West Side)	-	 (g) From a point 15m south of its junction with the southern end of Bolingbroke Road to a point 15m north of that junction. (h) From a point 15m south of its southern junction with Losinga Crescent to a point 15m north of that junction. (i) From a point 15m south of its junction with Suckling Avenue to a point 15m north of that junction. (j) From a point 25m south of its northern junction with Losinga Crescent to a point 15m north of that junction. (k) From a point 25m south of its junction with the northern end of Bolingbroke Road to a point 15m north of that junction.

Insert the following references:

A140 Aylsham Road (East Side)	-	From a point 33m north of its junction with Baxter Court southwards to a point 48 metres south of the centreline of its junction with the U41407/12 Bolingbroke Road.
A140 Aylsham Road (West Side)	-	From a point 20 metres north of the centreline of its junction with the U41407/22 Bolingbroke Road southwards to a point 16 metres south of the centreline of its junction with the U41407/12 Bolingbroke Road, a distance of 400 metres.
