

THE NORFOLK COUNTY COUNCIL
(PORINGLAND, VARIOUS ROADS) (20 M.P.H. SPEED LIMIT) ORDER 2019

The Norfolk County Council in exercise of its powers under Section 84 and 122 and parts III and IV of Schedule 9 of the Road Traffic Regulation Act 1984 (hereinafter referred to as "the Act"), having given public notice in accordance with sub-section (2) of that section and having consulted the Chief Officer of Police in accordance with paragraph 20 of Part III of Schedule 9 to the Act, hereby makes the following Order:

1. This Order may be cited as the Norfolk County Council (Poringland, Various Roads)(20 m.p.h. Speed Limit) Order 2019 and shall come into effect on the 30th day of September 2019.
2. No person shall cause or permit any vehicle to proceed at a speed exceeding 20 miles per hour along the lengths of road specified in the Schedule to this Order.
3. The following Order will become revoked on the date of commencement of this Order as follows:-

"The Norfolk County Council (Poringland, Framingham Earl and Stoke Holy Cross) (30 m.p.h. and 40 m.p.h. Speed Limits) Order 1999" – insofar as

 - (a) that Order refers to its entries for:

U71238 Alder Close	U78152 Leafyoak Lane
U78380 Critoph Close	U71237 Meadow Way
U78437 Cromes Oak Close	U78334 West View
 - (b) the entries referred to in that Order for the following roads conflict with the entries specified in the Schedule to this Order.
 - (i) U78151 Carr Lane
 - (iii) U78153 Howe Lane
 - (iii) C187 Shotesham Road
4. No speed limit imposed by this Order applies to vehicles falling within regulation 3(4) of the Road Traffic Exemptions (Special Forces)(Variation and Amendment) Regulations 2011 when used in accordance with Regulation 3(5) of those Regulations.
5. Insofar as any provision of this Order conflicts with any provision of any previous Order relating to the lengths of road specified in the Schedule to this Order, that provision of this Order shall prevail.

SCHEDULE
In the Parish of Poringland

20 m.p.h. Speed Limit

- U71238 Alder Close - From its junction with the U71237 Meadow Way north-eastwards for its entire length.
- U71544 Baynes Close - From its junction with the U71540 Bellamy Way north-eastwards for its entire length.
- U71540 Bellamy Way - From its junction with the C187 Shotesham Road northwards for its entire length.
- U78151 Carr Lane (north – south) - From its junction with the C187 Shotesham Road northwards for a distance of 177 metres.
- U78151 Carr Lane (east - west) - From its junction with the B1332 The Street westwards for a distance of 200 metres.
- U78380 Critoph Close - From its junction with the C187 Shotesham Road south-eastwards for its entire length.
- U78437 Cromes Oak Close - From its junction with the U78151 Carr Lane northwards for its entire length.
- U78153 Howe Lane - From its junction with the C187 Shotesham Road southwards for a distance of 10 metres.
- U78152 Leafyoak Lane - From its junction with the C187 Shotesham Road southwards for a distance of 105 metres.
- U71237 Meadow Way - From its junction with the C187 Shotesham Road north-westwards for its entire length.
- C187 Shotesham Road - From a point 33 metres west of its junction with the U78151 Carr Lane north-eastwards to a point 43 metres south-west of its junction with the B1332 The Street.
- From its junction with the B1332 The Street westwards for a distance of 200 metres.
- U78334 West View - From its junction with the U71852 Leafyoak Lane north-eastwards to its junction with the C187 Shotesham Road.
