THE NORFOLK COUNTY COUNCIL (COSTESSEY, WEST END) (PROHIBITION OF WAITING) AMENDMENT ORDER 2021

The Norfolk County Council (hereinafter referred to as "the Council") in exercise of their powers under Sections 1(1), 2(1), 2(2) and 4 and 122 and Parts III and IV of Schedule 9 of the Road Traffic Regulation Act 1984 (hereinafter referred to as "the Act") and the Traffic Management Act 2004 and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the 1984 Act hereby make the following Order:-

- This Order may be cited as The Norfolk County Council (Costessey, West End) (Prohibition of Waiting) Amendment Order 2021 shall come into effect on the 22nd day of March 2021.
- 2. References to West End in The Norfolk County Council (Various Roads) (Prohibition of Waiting) Consolidation and Variation Order 2011 are amended as set out in the Schedule to this Order.
- 3. Insofar as any provision of this Order conflicts with any provision of any previous Order relating to the lengths of road specified in the Schedule to this Order, that provision of this Order shall prevail.

SCHEDULE In the Town of Costessey

Prohibition of Waiting – At Any Time

Delete the following reference:

C171 West End North Side	-	From a point 15 metres west of the centreline of its junction with the C162 Longwater Lane eastwards for a distance of 105 metres.

Insert the following references:

C171 West End North Side	-	From a point 15 metres west of the centreline of its junction with the C162 Longwater Lane eastwards for a distance of 124 metres.
C171 West End South Side	-	From a point 15 metres west of the centreline of its junction with the C162 Longwater Lane eastwards for a distance of 85 metres.
	-	From a point 89 metres north-east from its junction with C162 Longwater Lane north-eastwards for a distance of 37 metres.

C162 West End North Side	-	From its junction with the C162 The Street south-westwards for a distance of 2.5 metres.
	-	From a point 7 metres west from its junction with 71485/10 Cleves Way north-eastwards for a distance of 19 metres
	-	From a point 28 metres north-east from its junction with the 71485/10 Cleves Way north-eastwards for a distance of 15 metres.
	-	From a point 59 metres north-east from its junction with the 71485/10 Cleves Way north-eastwards for a distance of 14 metres.
C162 West End South Side	-	From its junction with the C171 Town House Road south- westwards to a point 17 metres south-west of the centreline of its junction with the U71485 Cleves Way.
