THE NORFOLK COUNTY COUNCIL (GREAT YARMOUTH, BREWERY PLAIN) (STREET PARKING PLACES, MOTOR CYCLES) AMENDMENT ORDER 2019

The Norfolk County Council in exercise of their powers under Sections 1(1), 2(1), 2(2) and 4(2) and 122 and Parts III and IV of Schedule 9 of the Road Traffic Regulation Act 1984 (hereinafter referred to as "the 1984 Act") and the Traffic Management Act 2004 and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the 1984 Act hereby make the following Order:-

1. Citation and Commencement

This Order may be cited as The Norfolk County Council (Great Yarmouth, Brewery Plain) (Street Parking Places) Amendment Order 2019 and shall come into operation for all purposes on the 15th day of April 2019.

- 2. The Norfolk County Council (Great Yarmouth, Various Roads (Area 1)) (Street Parking Places) Order 2015 is amended by the deletion of the length of road set out in the Schedule to this Order.
- 3. Insofar as any provision of this Order conflicts with any provision of any previous Order relating to the lengths of road specified in the Schedule to this Order, that provision of this Order shall prevail.
