## THE NORFOLK COUNTY COUNCIL (SWAFFHAM, MARKET PLACE AND LONDON STREET) (LOADING BAY) AMENDMENT ORDER 2018

The Norfolk County Council (hereinafter referred to as "the Council") in exercise of its powers under Section 1(1) and 2(1) to (2), and 4(1) and 122 and Parts III and IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act") and the Traffic Management Act 2004 (hereinafter referred to as "the 2004 Act") and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby make the following Order:-

- 1. This Order may be cited as The Norfolk County Council (Swaffham, Market Place and London Street) (Loading Bay) Amendment Order 2018 and shall come into operation for all purposes on the 25<sup>th</sup> day of June 2018.
- 2. The Norfolk County Council (Swaffham, Market Place and London Street) (Loading Bay) Consolidation Order 2012 (hereinafter referred to as the "2012 Order") is amended as specified in Article 3 and 4 of this Order.
- 3. Schedule 1 of the 2012 Order is amended by the deletion of the length of Market Place as set out in the Schedule to this Order.
- 4. Schedule 2 of the 2012 Order is amended by the addition of the length of Market Place as set out in the Schedule to this Order.
- 4. In so far as any provision of this Order conflicts with any previous Order relating to the lengths of road specified in the Schedule to this Order, that provision of this Order shall prevail.
