

**THE NORFOLK COUNTY COUNCIL (ATTLEBOROUGH, VARIOUS ROADS)  
(STREET PARKING PLACES AND DISABLED PARKING PLACES) AMENDMENT  
ORDER 2018**

The Norfolk County Council (hereinafter referred to as "the Council") in exercise of its powers under Section 32(1) and 35(1) and Parts III and IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act") and the Traffic Management Act 2004 (hereinafter referred to as "the 2004 Act") and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby make the following Order:-

1. This Order may be cited as The Norfolk County Council (Attleborough, Various Roads) (Street Parking Places and Disabled Parking Places) Amendment Order 2018 and shall come into operation for all purposes on the 1<sup>st</sup> day of October 2018.
2. The Norfolk County Council (Attleborough, Various Roads) (Street Parking Places and Disabled Parking Places) Consolidation Order 2011 is amended as specified in Articles 3 and 4 of this Order.
3. Schedule 1 is deleted in its entirety
4. Schedule 4 is amended by the deletion and insertion of the references as specified in the Schedule below.
5. In so far as any provision of this Order conflicts with any previous Order relating to the lengths of road specified in the Schedule to this Order, that provision of this Order shall prevail.
