THE NORFOLK COUNTY COUNCIL (GREAT YARMOUTH, (MARINE PARADE AND REGENT ROAD/SOUTH MARKET ROAD) (PROHIBITION OF STOPPING ON FOOTWAY) ORDER 2015

The Norfolk County Council (hereinafter referred to as "the Council") in exercise of their powers under Sections 1(1), 2(1), 2(2) and 4 and 122 and Parts III and IV of Schedule 9 of the Road Traffic Regulation Act 1984 (hereinafter referred to as "the Act") and the Traffic Management Act 2004 (hereinafter referred to as "the 2004 Act") and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby make the following Order:-

- 1. This Order shall come into operation on the 27th day of March 2015 and may be cited as The Norfolk County Council (Great Yarmouth, Marine Parade and Regent Road/South Market Road) (Prohibition of Stopping on Footway) Order 2015.
- 2. In this Order –

Any reference to any enactment shall be construed as a reference to that enactment as amended, applied, consolidated, re-enacted by or as having effect by virtue of any subsequent enactment. Where the context otherwise requires the following expressions have the meaning hereby respectively assigned to them.

"authorised parking place" means any parking place on a road authorised or designated by an order made or having effect as if made under the Act;

"Civil Enforcement Officer" has the same meaning as in section 76 of the 2004 Act;

"Driver" in relation to a vehicle waiting in contravention of an Order, means the person driving the vehicle at the time it was left at that contravention;

"General Directions" shall mean The Traffic Signs Regulations and General Directions 2002"

"General Regulations 2007" shall mean The Civil Enforcement of Parking Contraventions (England) General Regulations 2007";

"Motor Car", Motor Cycle" and Invalid Carriage" have the same meaning as in section 136 of the Act;

"Penalty Charge" has the same meaning as in section 2 of the General Regulations 2007;

"Penalty Charge Notice" has the same meaning as in section 8 of the General Regulations 2007;

"the 1997 Regulations" shall mean the Zebra, Pelican and Puffin Pedestrian Crossing Regulations 1997.

- 3.(1) Save as provided in Article 4 of this order no person shall, except upon the direction or with the permission of a police constable in uniform or of a Civil Enforcement Officer, cause or permit any vehicle to stop along the lengths of footway specified in Schedule 1 to this Order.
- 3.(2) Save as provided in Articles 4 and 5 of this order no person shall, except upon the direction or with the permission of a police constable in uniform or of a Civil Enforcement Officer, cause or permit any vehicle to stop along the length of footway specified in Schedule 2 to this Order.
- 3.(3) The following Order will become revoked on the date of commencement of this Order as follows:-

"The Norfolk County Council (Great Yarmouth, Marine Parade)(Pedestrianised Area – Prohibition of Vehicles) Order 2008" – in its entirety.

- 4. Nothing in Article 3 of this Order shall apply so as to prevent any person from causing a vehicle to stop along the lengths of road specified in that Article if the vehicle is being used:
 - (a) for fire brigade, police or ambulance purposes;
 - (b) in the service of a local authority or water authority in pursuance of statutory powers or duties;
 - (c) in connection with the maintenance, improvement or reconstruction of that length of road or the laying, erection, alteration or repair in or adjacent to that length of road of any sewer, water, gas, or electricity apparatus or of any telecommunications apparatus as defined in the Telecommunications Act 1984;
 - (d) for the provision of a universal postal service as defined in the Postal Services Act 2000.
- 5. Nothing in Article 3(2) of this Order shall apply so as to prevent any person from causing a vehicle to stop for the purposes of loading and/or unloading of that vehicle between 0700 hours and 1000 hours and between 2200 hours and midnight.
- 6. Insofar as any provision of this Order conflicts with any provision of any previous Order relating to the lengths of road specified in the Schedule to this Order, that provision of this Order shall prevail.
