THE NORFOLK COUNTY COUNCIL (WYMONDHAM, VARIOUS ROADS) (PROHIBITION OF WAITING) AMENDMENT ORDER 2017

The Norfolk County Council in exercise of their powers under Sections 1(1), 2(1), 2(2) and 4(2) and 122 and Parts III and IV of Schedule 9 of the Road Traffic Regulation Act 1984 and the Traffic Management Act 2004 and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby make the following Order:-

- 1. This Order may be cited as The Norfolk County Council (Wymondham, Various Roads) (Prohibition of Waiting) Amendment Order 2017 and shall come into operation for all purposes on the 11th day of September 2017.
- 2. The Norfolk County Council (Wymondham, Various Roads) (Prohibition of Waiting) Consolidation and Variation Order 2011 is amended in Schedule 1 by the addition of the lengths of roads as specified in the Schedule to this Order.
- 3. Insofar as any provision of this Order conflicts with any provision of any previous Order relating to the lengths of road specified in the Schedule to this Order, that provision of this Order shall prevail.
