### **Norwich City**

Examination Hearings took place in January to March 2022 with additional hearings ongoing as of September 2022, including an additional hearing for East Norwich which was held on 6 July. A public consultation on Gypsy and Traveller sites is scheduled to take place from 30 January to 13 March 2023. Adoption is currently anticipated in Early 2024.
- East Norwich Masterplan: Stage 1 approved at Cabinet November 2021 (high • level masterplan based on a preferred option, understanding of strategic infrastructure needs, other costs, and impact on deliverability). Stage 2 completed by May 2022 (includes Infrastructure Delivery Plan and Strategic Viability Assessment to inform a refined version of the masterplan). Stage 2 was reported to Cabinet in June 2022 where the masterplan was approved, and other outputs including a draft SPD were endorsed. This work will form the basis of a new joint East Norwich SPD (with South Norfolk Council and the Broads Authority) to support the policy within the Greater Norwich Local Plan and will be adopted following, or alongside, adoption of the Greater Norwich Local Plan. A Stage 3 study, led and funded by Homes England, is currently underway, building on the masterplan outputs. This commenced in October and is anticipated to be completed in early 2023. It includes financial modelling and assessment of delivery options, and will assist partners to put in place a delivery strategy for the East Norwich development.

### South Norfolk
