

**THE NORFOLK COUNTY COUNCIL (BAWSEY, MINTLYN WOOD ROAD)**  
**(PROHIBITION OF MOTOR VEHICLES) EXPERIMENTAL ORDER 2021**

The Norfolk County Council has made the above Experimental Order under the Road Traffic Regulation Act 1984 in order to prohibit the use by motor vehicles of the U22108 Mintlyn Wood Road from 484 metres south of its junction with the B1145 Lynn Road to its junction with the C55 Brow of the Hill in the Parish of Bawsey. The restriction will be in operation between the 1<sup>st</sup> April and 1<sup>st</sup> November (both dates inclusive) every year and would not apply to emergency service vehicles or motor cycles.

The Order was made on 6<sup>th</sup> September 2021 and comes into effect for all purposes on 20<sup>th</sup> September 2021. This Experimental Order will be in force for a period not exceeding 18 months. However, consideration will be given in due course as to whether to make an Order for its provisions to continue in force indefinitely. Within a period of six months beginning with the 20<sup>th</sup> September 2021, or if this Order varied by another Order or modified pursuant to Section 10(2) of the Road Traffic Regulation Act 1984, beginning with the day on which the variation or modification came into force, any person may object to the making of an Order for the purpose of such indefinite continuation.

The provisions of the Order are experimental and the Executive Director of Community and Environmental Services or a person delegated to by him is authorised to make changes if necessary for safety and operational reasons as set out in Section 10 (2) (a) and (c) of the Road Traffic Regulation Act 1984.

However, during the current pandemic staffing levels have been reduced and viewing online would be recommended in keeping with the government guidelines.

Any person who desires to question the validity of the Order or of any provision contained in it on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1984, or on the grounds that any requirement of that Act, or of any instrument made under it, has not been complied with in relation to the Order, may within six weeks from 6<sup>th</sup> September 2021 apply to the High Court for this purpose.
