## THE NORFOLK COUNTY COUNCIL (ATTLEBOROUGH QUEENS SQUARE) (PROHIBITION OF MOTOR VEHICLES) ORDER 2020

The Norfolk County Council in exercise of their powers under Sections 1(1) 2(1) to (3) and 3(2) and 122 and parts III and IV of Schedule 9 of the Road Traffic Regulation Act 1984 (hereinafter referred to as "the Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby make the following Order:

1. This Order shall be cited as The Norfolk County Council (Attleborough, Queens Square) (Prohibition of Motor Vehicles) Order 2020 and come into operation on the 2<sup>nd</sup> day of November 2020.

## 2. In this Order:

Any reference to any enactment shall be construed as a reference to that enactment as amended, applied, consolidated, re-enacted by or as having effect by virtue of any subsequent enactment. Where the context otherwise requires the following expressions have the meaning hereby respectively assigned to them.

"keyholders" shall mean the Attleborough Town Council and Norfolk County Council or organisations appointed by those bodies to be responsible for the holding of the keys to the lockable bollards placed restricting the use of the length of the U33189 Queens Square set out in Article 3 of this Order;

"motor vehicle" has the same meaning as in section 185 of the Road Traffic Act 1988";

"Class 1, Class 2 and Class 3 vehicles" have the same meaning as in s3 of The Use of Invalid Carriages on Highways Regulations 1988.

- 3. Save as provided in Article 4, no person shall, except with the use of the keys obtained from the keyholders or upon the direction of, or with the permission of a police constable in uniform cause any motor vehicle to proceed along the U33189 Queens Square at its western junction with the B1077 Queens Square/Church Street for a distance of 4 metres northwards.
- 4. Nothing in Article 3 of this Order shall apply so as to prevent any person from causing a vehicle to proceed in the lengths of road specified in that Article if the vehicle being used:
  - (a) for fire brigade, police or ambulance purposes;
  - (b) in the service of a local authority or water authority in pursuance of statutory powers or duties;
  - (c) in connection with the maintenance, improvement or reconstruction of that length of road or the laying, erection, alteration or repair in or adjacent to that length of road of any sewer, water, gas, or electricity

apparatus or of any telecommunications apparatus as defined in the Telecommunications Act 1984:

- (e) for the provision of a universal postal service as defined in the Postal Services Act 2011:
- (f) is a Class 1, Class 2 or Class 3 vehicle;
- (g) requires access to properties on U33189 Queens Road.
- 5. Insofar as any provision of this Order conflicts with any provision of any previous Order relating to the lengths of road specified in Article 3 of this Order, that provision of this Order shall prevail.
