THE NORFOLK COUNTY COUNCIL (GREAT YARMOUTH, MARINE PARADE, NORTH DRIVE AND SOUTH BEACH PARADE) (PROHIBITION OF WAITING) AMENDMENT ORDER 2019

The Norfolk County Council in exercise of their powers under Sections 1(1), 2(1), 2(2) and 4(2) and 122 and Parts III and IV of Schedule 9 of the Road Traffic Regulation Act 1984 (hereinafter referred to as "the Act") and the Traffic Management Act 2004 (hereinafter referred to as "the 2004 Act") and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby make the following Order:-

- 1. This Order may be cited as The Norfolk County Council (Great Yarmouth, Marine Parade, North Drive and South Beach Parade) (Prohibition of Waiting) Amendment Order 2019 and shall come into operation for all purposes on the 22nd day of April 2019.
- The Norfolk County Council (Great Yarmouth, Marine Parade, North Drive and South Beach Parade) (Prohibition of Waiting) Consolidation Order 2012 (hereinafter referred to as the "2012 Order") is amended by the addition of the lengths of road as specified in the Schedule 1 and 2 to this Order.
- 3. The following paragraph is added as Article 3. (vi) of the 2012 Order:
 - on Monday to Saturday from 0800 hours to 1800 hours along the lengths of road specified in Schedule 5
- 4. Schedule 5 is added to the 2012 Order containing the details specified in Schedule 2 to this Order.
- 5. Insofar as any provision of this Order conflicts with any provision of any previous Order relating to the lengths of road specified in the Schedule to this Order, that provision of this Order shall prevail.
