

**THE NORFOLK COUNTY COUNCIL
(TROWSE WITH NEWTON, WHITLINGHAM LANE)
(PROHIBITION OF WAITING) AMENDMENT ORDER 2020**

The Norfolk County Council in exercise of their powers under Sections 1(1), 2(1), 2(2) and 4 and 122 and Parts III and IV of Schedule 9 of the Road Traffic Regulation Act 1984 (hereinafter referred to as “the Act”) and the Traffic Management Act 2004 (hereinafter referred to as “the 2004 Act”) and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby make the following Order:-

1. This Order may be cited as The Norfolk County Council (Trowse with Newton, Whitlingham Lane) (Prohibition of Waiting) Amendment Order 2020 and shall come into operation for all purposes on the 2nd November 2020.
2. The Norfolk County Council (Trowse with Newton, Various Roads) (Prohibition of Waiting) Order 2014 (hereinafter referred to as the “2014 Order”) is amended as specified in Articles 3 and 4 and the Schedule to this Order.
3. The following wording is added as Article 3(2) to the 2014 Order:-

“3.(2) Save as provided in Article 4 of this Order no person shall, except upon the direction or with the permission of a police constable in uniform or of a Civil Enforcement Officer, cause or permit any vehicle to wait along the lengths of road specified in Schedule 2 to this Order between 2300 hours and 0700 hours.”
4. References to the U78185 Whitlingham Lane in the Schedule to the 2014 Order are amended as set out in Schedule 1 to this Order.
5. The lengths of road specified in Schedule 2 to this Order are added as Schedule 2 in the 2014 Order.
6. Insofar as any provision of this Order conflicts with any provision of any previous Order relating to the lengths of road specified in the Schedule to this Order, that provision of this Order shall prevail.

	-	From a point 715 metres north-east of its junction with the C202 The Street north-east for a distance of 122 metres.
	-	From a point 868 metres north-east of its junction with the C202 The Street north-east for a distance of 121 metres.



	-	From a point 436 metres north-east of its junction with the C202 The Street north-eastwards for a distance of 75 metres.
	-	From a point 606 metres north-east of its junction with the

		C202 The Street north-eastwards for a distance of 27 metres.
	-	From a point 649 metres north-east of its junction with the C202 The Street north-eastwards for a distance 66 metres.
	-	From a point 837 metres north-east of its junction with the C202 the street north-eastwards for a distance of 31 metres.
