### Welcome, introductions and Apologies

1.1. All members and officers introduced themselves and apologies were noted (as above).

### 2. Minutes and Matters Arising from Meeting of 14th December 2021

2.1. Previous minutes agreed as accurate.

#### 3. Water Resources East – Julia Beeden

- 3.1. Julia Beeden, Norfolk Water Strategy Programme Manager, from WRE, gave Members a presentation on the overview of the current running Emerging Water Resources Regional Plan Consultation. She updated Members on the engagement timeline, processes, demand management options etc. The raison d'etre of the strategy is to test scaled up natured based solutions can deliver benefits for water management, and develop a collaborative partnership platform to deliver natured based solutions and for mobilising funding for these proposed infrastructures.
- 3.2. There is a long term, phased regional plan in place to deal with demand management of the Eastern region. There are many different supply options being considered. Julia talked specifically about the Fens Reservoir as part of the option for demand management. The main purpose is trying to find effective solutions to balance economic growth with environmental sustainability.
- 3.3. Cllr Plant raised the importance of climate change to the Norfolk Water Strategy.

  Julia assured that water should not be a barrier to agricultural and economic growth.
- 3.4. Members discussed options of capturing flood water for economic usage as part of the long-term solution to address water supply.
- 3.5. Julia actively encouraged all Members to participate in the consultation.

#### 4. Work Programme Update – Trevor Wiggett

- 4.1. Trevor gave the forum an update on projects within the work programme. A paper detailing all the latest progress has been produced for the forum. For GI Rams, a county wide statement of common ground between all LPAs in Norfolk and Natural England is being finalised by officers.
- 4.2. In term of governance arrangement of delivering the GI Rams, a steering group has been set up to create term of reference for the overarching board, and formal arrangements are being worked on with the County to be the accountable body and hosting organisation.
- 4.3. The brief for the New Rams Mitigation Package review study is being finalised.
- 4.4. For Planning in Heath Protocol, the review for the latest iteration is underway. The review will focus on :
  - Updating of NHS and ICS structures
  - Checking the current engagement and feedback process from both planning and NHS perspective
  - Inclusion of Infrastructure Delivery Plan

- Building in principles of healthy design and reviewing the checklist
- 4.5. The older persons accommodation and Support Needs Study is now complete.
