Background

An officer group has been set up to review and recommend the best approach to the NSF public consultation and then deal with the work involved. The group have also engaged with Communication Officers and the Consultation and Engagement team from the Norfolk County Council. The public consultation will be hosted via the Norfolk County Council Website. The recommendations of the group are contained in this report and have been review by the NSPG on the 6th July.

Consultation Timescales

In order to fit with the current project timescales the following dates for the consultation are recommended:

Consultation start: 1st August 2017

Consultation finishes: 4pm on the 22nd September 2017

Consultation Publicity

Officers have previously suggested that because of the nature of the document the consultation only needs low key publicity, it should be focussed on key stakeholders but also allow the wider public to comment if they wish. The sub group recommend the following:

- A press release is made which may include comments from the chair of the member forum.
- No public meetings or public events are held

Consultation Documentation Availability

Public consultation sub group recommend:

- The NSF document and supporting documentation is available on the county website. See Appendix 1 for suggested website text.
- Hard copies of the NSF (with supporting documents on request) made available to view at district council, the County Council and Broads Authority offices. Each Authority can circulate wider if they wish to or are required to by their established practices or SCIs
- A set of FAQs is produced to support the consultation

Consultees

It is recommended that correspondence regarding the NSF Public Consultation is sent to the same consultees as used for the HELAA methodology, this included parishes, neighbouring authorities, developers, agents and other public bodies subject to the duty to cooperate. See Appendix 2 for suggest text for the email to consultees.

As the HELAA Methodology was completed over a year ago all authorities will be asked to review their consultees list to ensure it is up to date. This will need to be completed by the 17th July.

Responses

The group recommend that responders are encouraged to use an on-line response form. See appendix 3 for suggested response form.

An acknowledgement will be sent confirming receipt of the response.

Responses can also be made via a dedicated county email address although this will be discouraged.

No phone number will be made available to discuss the NSF.

Should a responder want to send a response by post, a postal address will be provided on request.

Dealing with Responses

Responses will initially be logged by the NSF support staff.

A nominated officer is required to review and draft up an initial response to any comments as they are received.

These will then be reviewed by the steering group, NSPG and finally the member forum.

Budget

Only minor printing cost are envisaged at this stage. If Authorities wish to circulate paper copies to a wider audience they will be responsible for printing.

Appendix 1 – Draft text for consultation web page

Working together as part of the duty to co-operate all of the Norfolk Planning Authorities, together with others, have prepared a strategic framework document. We are now publishing the first draft of the framework for consultation.

The Norfolk Strategic Framework covers the whole of the County and aims to provide high level strategic guidance to inform the preparation of the next round of Local Plans which are being prepared by each of the Planning Authorities in the County. The document is not a formal plan and consequently it makes no specific development proposals nor does it include any planning policies. Rather the intention is that each of the planning authorities will endorse a set of Agreements included within the Framework which they will then aim to achieve when they prepare their respective local plans.

The document explains the main demographic, household and employment forecasts and how these affect the future development needs of the County, outlines national planning policy requirements, and includes high level visions relating to the economy, climate change, housing, quality of life and the environment.
