## **GENERAL VESTING DECLARATION**

**of Norfolk County Council**

in respect of land parallel to 96/98, Harvey Lane, Norwich (NR7  
0AQ) (having an area of 116.9 m<sup>2</sup>)

This **GENERAL VESTING DECLARATION** is executed on the 18<sup>th</sup> December 2023 by **NORFOLK COUNTY COUNCIL** (“the Authority”)

**WHEREAS:**

(1) On 12<sup>th</sup> December 2023 an order entitled The Norfolk County Council (A1042 Heartsease Fiveways Roundabout Junction Improvement Scheme) Compulsory Purchase Order 2023 was confirmed by the Secretary of State under the powers conferred on them by the Highways Act 1980 and Acquisition of Land Act 1981 authorising the Authority to acquire the land specified in the Schedule hereto.

(2) Notice of the confirmation of the order was first published in accordance with section 15 of the Acquisition of Land Act 1981 on 15<sup>th</sup> December 2023.

(3) That notice included the statement and form prescribed under section 15(4)(e) and (f) of the Acquisition of Land Act 1981

**NOW THIS DEED WITNESSETH** that, in exercise of the powers conferred on them by section 4 of the Compulsory Purchase (Vesting Declarations) Act 1981 (“the Act”), the Authority hereby declare:-

The land described in the Schedule hereto (being part of the land authorised to be acquired by the order) and more particularly delineated on the plan annexed hereto, together with the right to enter and take possession of the land shall vest in the Authority as from the end of the period of 3 months from the date on which the service of notices required by section 6 of the Act is completed.
