COMPULSORY PURCHASE ORDER 2024**

COMPULSORY PURCHASE OF LAND ADJACENT TO A1047 DEREHAM ROAD

1. Notice is hereby given that The Norfolk County Council has made The Norfolk County Council (A1047 Dereham Road Scheme) Compulsory Purchase Order 2024 under section 239 of the Highways Act 1980. It is about to submit this Order to the Secretary of State for confirmation, and if confirmed, the Order will authorise The Norfolk County Council to purchase compulsorily the land described below for the purpose of improving the A1074 Dereham Road.

2. A copy of the Order and of the accompanying map may be seen at the offices of Norfolk County Council, County Hall, Martineau Lane, Norwich, Norfolk, NR1 2DH and may be seen at all reasonable hours. 3. Any objection to the Order must be made in writing to the Secretary of State for Transport, National Transport Casework Team, Department for Transport, Tyneside House, Skinnerburn Road, Newcastle Business Park, Newcastle-upon-Tyne, NE4 7AR before 12th March 2024 and should state the title of the Order, the grounds of objection and the objector's address and interests in the land. Please, if possible, also send a copy of the objection by e-mail to NATIONALCASEWORK@dft.gov.uk in addition to posting. In submitting an objection, it should be noted that your personal data and correspondence will be passed by the Secretary of State for Transport to the Acquiring Authority to enable your objection to be considered. Where the Order becomes the subject of Public Local Inquiry procedures, all correspondence is copied to the Inspector conducting the Inquiry and will be kept in the Public Inquiry library, where it is publicly available. If you do not wish your personal data to be forwarded, please state your reasons when submitting your objection and the Secretary of State will copy your representations, with your name and address removed to the Acquiring Authority and if there is to be a Public Local Inquiry they will be seen by the Inspector, who may give them less weight as a result.
