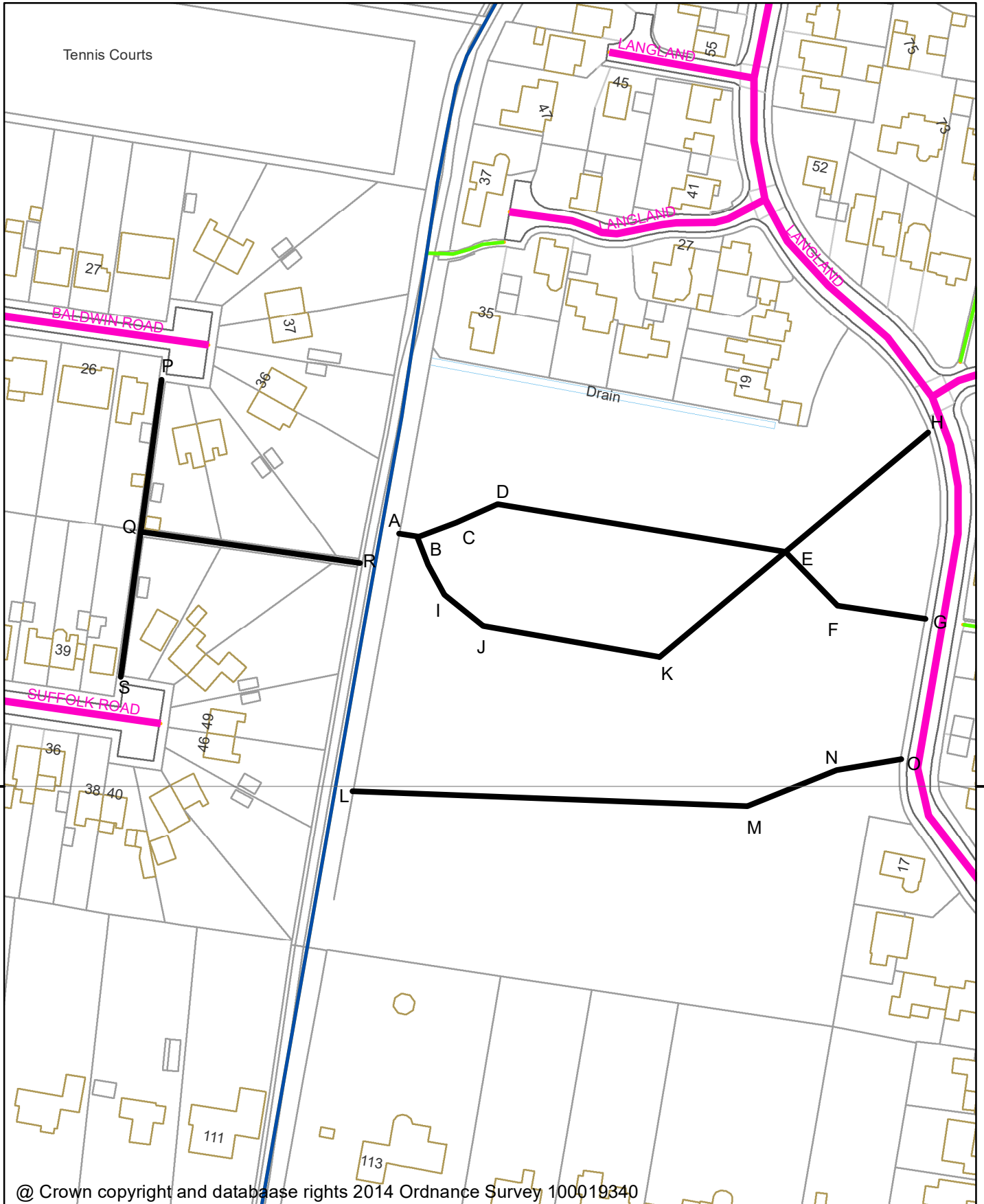
Spring Wood, King's Lynn Confirmed Application Plan

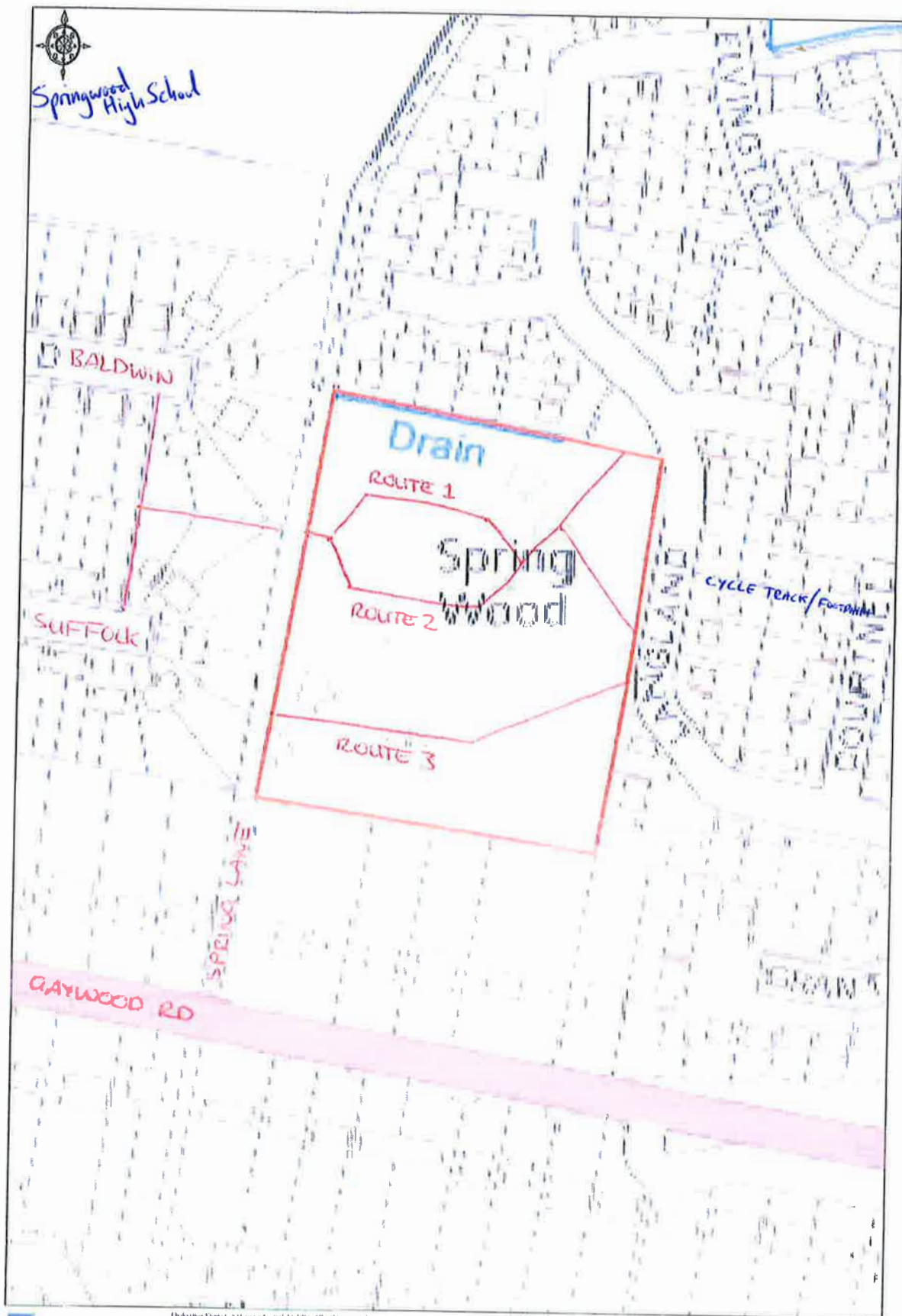
