

**THE NORFOLK COUNTY COUNCIL
(BURNHAM MARKET, FOUNDRY PLACE, HERRING'S LANE, NORTH STREET)
(PROHIBITION OF WAITING) AMENDMENT ORDER 2020**

The Norfolk County Council in exercise of their powers under Sections 1(1), 2(1), 2(2) and 4(2) and 122 and Parts III and IV of Schedule 9 of the Road Traffic Regulation Act 1984 (hereinafter referred to as "the Act") and the Traffic Management Act 2004 and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby make the following Order:-

1. This Order may be cited as the "The Norfolk County Council (Burnham Market, Foundry Place, Herring's Lane, North Street) (Prohibition of Waiting) Amendment Order 2020 and shall come into effect for all purposes on the 10th day of August 2020.
2. The Norfolk County Council (Burnham Market, Various Roads) (Prohibition of Waiting) Order 2015 is amended by the deletion and the insertion of the references as specified in the Schedule to this Order.
3. Insofar as any provision of this Order conflicts with any provision of any previous Order relating to the lengths of road specified in the Schedule to this Order, that provision of this Order shall prevail.

In the Parish of Burnham Market

Prohibition of Waiting - At Any Time

Delete the following references:

B1155 North Street (North side)	-	From a point 17 metres east of the centreline of its junction with the B1355 Bellamy's Lane westwards for a distance of 32 metres
	-	From a point 33 metres west of the centreline of its junction with the B1355 Bellamy's Lane westwards for a distance of 35 metres.
	-	From a point 110 metres west of the centreline of its junction with the B1355 Bellamy's Lane westwards for a distance of 108 metres.

Prohibition of Waiting - At Any Time

Insert the following references:

U23754 Foundry Place (Both sides)	-	From its junction with B1155 North Street northwards for a distance of 66 metres.
U22165 Herring's Lane (Both sides)	-	From a point 45 north of its junction with U22349 Market Place northwards for a distance of 267 metres.

B1155 North Street (North side)	- From a point 17 metres east of the centreline of its junction with the B1355 Bellamy's Lane westwards to its junction with the U23754 Foundry Place.
