

**THE NORFOLK COUNTY COUNCIL
(HUNSTANTON, SOUTHEND ROAD)
(PROHIBITION OF WAITING) AMENDMENT ORDER 2017.**

The Norfolk County Council in exercise of their powers under Sections 1(1), 2(1), 2(2) and 4(2) and 122 and Parts III and IV of Schedule 9 of the Road Traffic Regulation Act 1984 (hereinafter referred to as "the 1984 Act") and the Traffic Management Act 2004 (hereinafter referred to as "the 2004 Act") and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby make the following Order:-

1. Citation and Commencement

This Order may be cited as the "The Norfolk County Council (Hunstanton, Southend Road) (Prohibition of Waiting) Amendment Order 2017 and shall come into effect for all purposes on the 30th day of October 2017.

2. The Norfolk County Council (Hunstanton, Various Roads) (Prohibition of Waiting Order) 2015 (hereinafter referred to as the "2015 Order") is amended as specified in Articles 3 and 4 of this Order.
3. In Schedule 1 of the 2015 references to Southend Road are amended as specified in Schedule 1 to this Order.
4. In Schedule 5 of the 2015 the reference to Southend Road is added as specified in Schedule 2 to this Order.
5. Insofar as any provision of this Order conflicts with any provision of any previous Order relating to the lengths of road specified in the Schedule to this Order, that provision of this Order shall prevail.
