

**THE NORFOLK COUNTY COUNCIL
CITY CENTRE CONTROLLED PARKING ZONE
(TOMBLANDTRIANGLE AND UPPER KING STREET)
AMENDMENT TRAFFIC REGULATION ORDER 2020**

The Norfolk County Council in exercise of powers under sections 1, 2, 4, 45, 46 and 122 and Parts III and IV of Schedule 9 of the Road Traffic Regulation Act 1984, (hereinafter referred to as "the Act") and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby make the following Order:-

1. Citation and Commencement

This Order may be cited as The Norfolk County Council (City Centre Controlled Parking Zone) (Tombland Triangle and Upper King Street) Amendment (Traffic Regulation Order 2020 and shall come into effect for all purposes on the 28th day of December 2020.

2. The Norwich City Council City Centre Controlled Parking Zone (Consolidation) Traffic Regulation Order 2003 (as amended) (hereinafter referred to as the "2003 Order") is amended as specified in Articles 4 to 17 of this Order.

3. The Norwich City Council (On Street Charging) Traffic Regulation Order 2001 (as amended) (hereinafter called the "2001 Order") is amended as specified in Article 18 of this Order.

4. The following paragraph is added as Article 4(48) to the 2003 Order:-

"A person may allow a vehicle to load or unload in any streets or parts of streets mentioned in Schedule 330 of this Order between the hours of 5.00am to 6.30pm on any day but no person may allow a vehicle to stop within these streets between the hours of 6.30pm and 5:00am unless it is a Licenced Hackney Carriage."

5. A Schedule 330 is added containing the details specified in Schedule 12 to this Order.

6. In Schedule 15 of the 2003 Order references to Tombland are amended as specified in Schedule 1 of this Order.


