

**THE NORFOLK COUNTY COUNCIL (REDENHALL WITH HARLESTON,
VARIOUS ROADS) (PROHIBITION OF WAITING, LOADING AND UNLOADING)
AMENDMENT ORDER 2019**

The Norfolk County Council (hereinafter referred to as "the Council") in exercise of their powers under Sections 1(1), 2(1), 2(2) and 4(1) and (2) and 122 and Parts III and IV of Schedule 9 of the Road Traffic Regulation Act 1984 (hereinafter referred to as "the Act") and the Traffic Management Act 2004 (hereinafter referred to as "the 2004 Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby make the following Order:-

1. This Order may be cited as the "The Norfolk County Council (Redenhall with Harleston, Various Roads) (Prohibition of Waiting, Loading and Unloading) Amendment Order 2019 and shall come into effect for all purposes on the 13th day of May 2019.
2. The Norfolk County Council (Redenhall with Harleston, Various Roads) (Prohibition of Waiting, Loading and Unloading) Consolidation Order 2011 (hereinafter referred to as the "2011 Order") is amended as set out in Articles 3, 4 and 5 of this Order.
3. The following paragraph replaces 3.(1) of the 2011 Order:

3(1). Save as provided in Article 4 of this Order no person shall, except upon the direction or with the permission of a police constable in uniform or of a Civil Enforcement Officer, cause or permit any vehicle to:

 - (i) wait, load or unload on Monday to Saturday from 0800 hrs to 1800 hrs along the length of road specified in Schedule 1 to this Order;
 - (ii) wait, load or unload on Wednesday from 0500 hrs to 1700 hrs along the lengths of road specified in Schedule 2 to this Order;
 - (iii) load or unload on Wednesday from 0500 hrs to 1700 hrs along the lengths of road specified in Schedule 3 to this Order.
4. Schedule 3 is inserted in the 2011 Order as set out in Schedule 1 to this Order.
5. Schedule 2 is amended by the deletion and insertion of the reference to Exchange Street as specified in Schedule 2 to this Order.
6. Insofar as any provision of this Order conflicts with any provision of any previous Order relating to the lengths of road specified in the Schedule to this Order, that provision of this Order shall prevail.

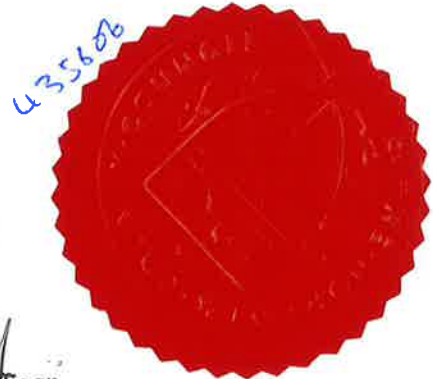
