

**THE NORFOLK COUNTY COUNCIL  
(WELLS-NEXT-THE-SEA, VARIOUS ROADS)  
(PROHIBITION OF LOADING AND UNLOADING) AMENDMENT ORDER 2020**

The Norfolk County Council in exercise of their powers under Sections 1(1), 2(1), 2(2) and 4 and 122 and Parts III and IV of Schedule 9 of the Road Traffic Regulation Act 1984 (hereinafter referred to as “the Act”) and the Traffic Management Act 2004 (hereinafter referred to as “the 2004 Act”) and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby make the following Order:-

1. This Order may be cited as The Norfolk County Council (Wells-Next-The-Sea, Various Roads) (Prohibition of Loading and Unloading) Amendment Order 2020 and shall come into operation for all purposes on the 6<sup>th</sup> day of April 2020.
2. The Norfolk County Council (Wells-Next-The-Sea, Various Roads) (Prohibition of Loading and Unloading) Order 2013 (hereinafter referred to as the “2013 Order”) is amended by the deletion and addition of the lengths of road as specified in the Schedules 1 and 2 to this Order.
3. Insofar as any provision of this Order conflicts with any provision of any previous Order relating to the lengths of road specified in the Schedule to this Order, that provision of this Order shall prevail.

**SCHEDULE 1**

**In the Town of Wells-Next-The-Sea**

**Prohibition of Loading and Unloading At Any Time**

U10033 Beach Road West Side	-	From its junction with C881 Freeman Street northwards for a distance of 50 metres
U10033 Beach Road East Side	-	From its junction with C881 The Quay northwards for a distance of 50 metres
C881 Freeman Street North Side	-	From a point 5 metres west of the mid-point of its junction with U10033 Beach Road westwards for a distance of 34 metres
C881 Freeman Street South Side	-	From the mid-point of its junction with U10033 Beach Road westwards for a distance of 39 metres
C881 The Quay South Side	-	From the mid-point of its junction with U10033 Beach Road eastwards for a distance of 32 metres

SCHEDULE 2

Delete the following reference from Schedule 2 of the 2013 Order:

Prohibition of Loading and Unloading – At Any Time – Good Friday to 30<sup>th</sup> September

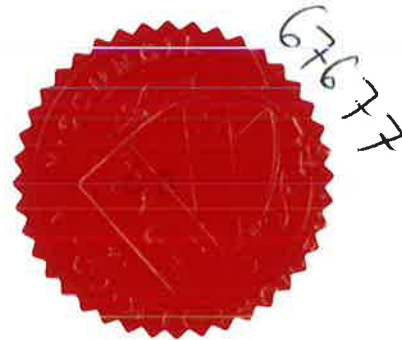


