

**The Commons Act 2006 – Section 19**  
**Notice of an Application for the correction of the Commons Register**

To every reputed owner, lessee, tenant or occupier of any part of the land described below, and to all others whom it may concern.

An application has been made to the Commons Registration Authority, Norfolk County Council, by Mr and Mrs Parker under section 19(2)(a) of the Commons Act 2006 and in accordance with the Commons Registration (England) Regulations 2014. The applicants seek the correction of the commons map and registers of CL 46, Mulbarton Common in the Parish of Mulbarton, Norfolk, by the removal of land and buildings which form the boundaries of the property known as 'Carpenters' (formerly 'Common View') Norwich Road, Mulbarton NR14 8JN as edged and shown cross hatched in black on the plan accompanying the application and attached to this Notice. The basis of the application is that the buildings and land were excluded from the original application for registration of Mulbarton Common dated 4 August 1967 but were mistakenly included by the Commons Registration Authority in the provisional registration of 16 October 1967, which being undisputed, became final on 1 October 1970. If the application is granted the Commons Registration Authority will give effect to the determination by removing the buildings and land edged and hatched in black from the register of common land.



- must state the grounds on which they are made; and

Any representations made will not be treated as confidential but will be dealt with in accordance with regulation 25. If the application is referred to the Planning Inspectorate for determination in accordance with regulation 26, any representations will be sent with it for consideration. The date on which the period for making representations expires is 10 June 2016.


