1. INTRODUCTION

- 1.1 An application made by Norfolk County Council (NCC) to the Planning Inspectorate under the Planning Act 2008 ("the Application") for an order granting development consent (the "DCO") referred to as The Norfolk County Council (Norwich Northern Distributor Road (A1067 to A47(T))) Order, was submitted on 7 January 2014. The application was accepted for examination on 4 February 2014.
- 1.2 This document relates to a procedural decision made under Section 89(3) of the Planning Act 2008, for additional information to be supplied to the Examining Authority. The request was included at point 1 of Annex F to the Examining Authority's letter dated 8 May 2014, issued pursuant to rule 6 of the Infrastructure Planning (Examination Procedure) Rules 2010.
- 1.3 This document relates to the Application and should therefore be read alongside the other Application documents.



2.0 INFORMATION REQUEST AND RESPONSE

"The ExA requests from the applicant a report on status of negotiations with affected persons in respect of compulsory acquisition for each plot.

This report should follow the Book of Reference, listing each plot and affected person. A report should be given on each on the status of negotiations between the applicant and such persons. This should include any matters outstanding, measures being taken and estimated timescales to resolution."

- 2.1 NCC has already acquired some areas of land required for the Scheme.
- 2.2 NCC remains open to acquiring other areas of land required for the Scheme (not already acquired). However, unless requested by the landowner, it is not generally pursuing the freehold transfer of land prior to the end of the examination period for the DCO application this reflects the view of many owners who may not want to sell land (or contract to do so) until the Scheme's consenting is further progressed. In addition to purchasing land where requested, NCC is also prepared to enter into option agreements where appropriate or where requested by the landowner.
- 2.3 Where negotiations and discussions are ongoing with remaining landowners and their representatives, these are largely focusing on detailed design and accommodation works issues, with financial compensation also being considered / agreed where possible.
- 2.4 The accommodation works agreements referred to will cover issues such as fencing, access gates and access tracks.



- 2.5 In general, no negotiations have been held with Category 2 parties such as mortgage companies and beneficiaries of agreements, as these will be dealt with, if appropriate, during the freehold legal acquisition process.
- 2.6 The letters used in the following table under 'Acquisition Type' have the following meanings:
