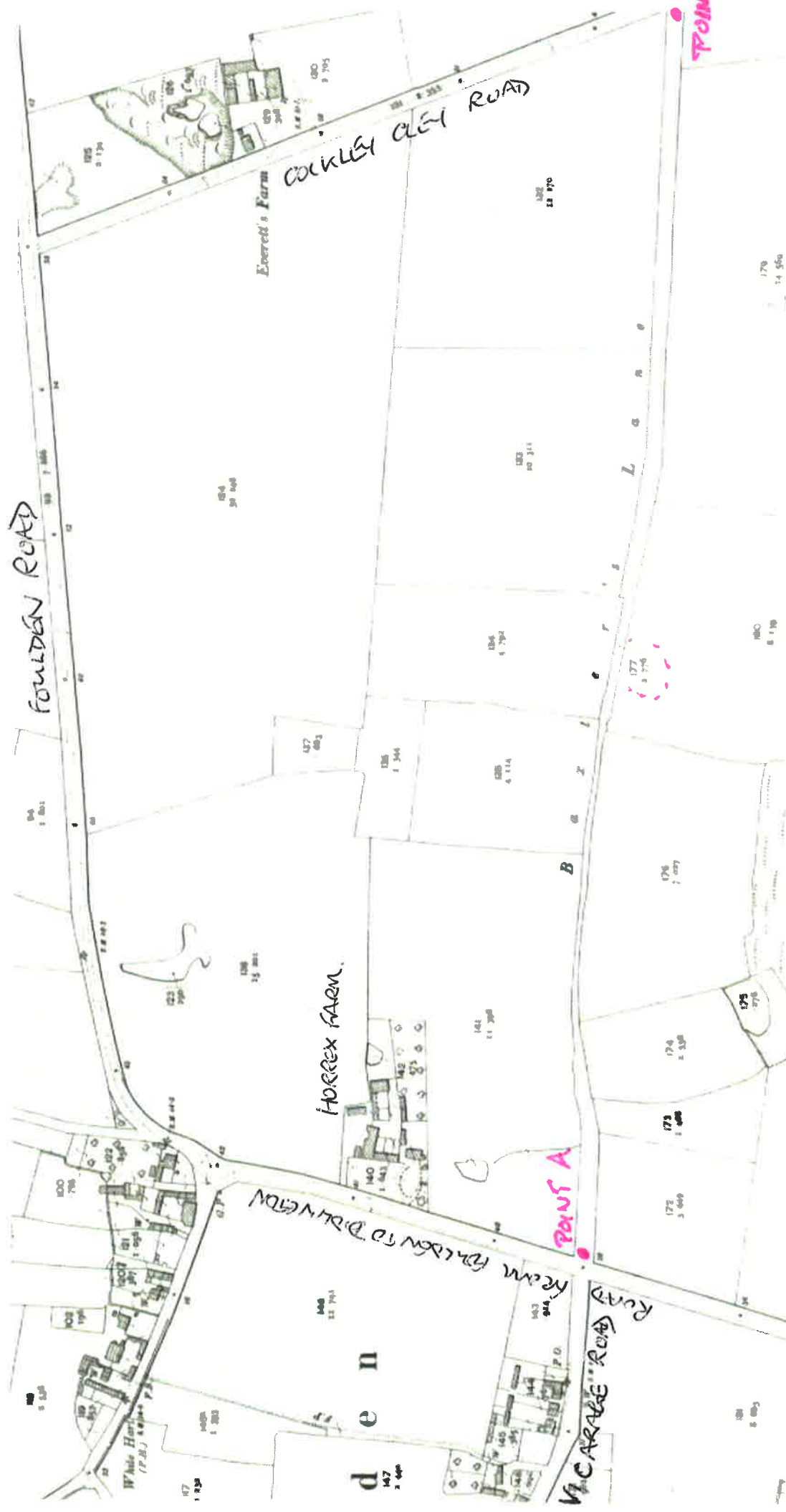
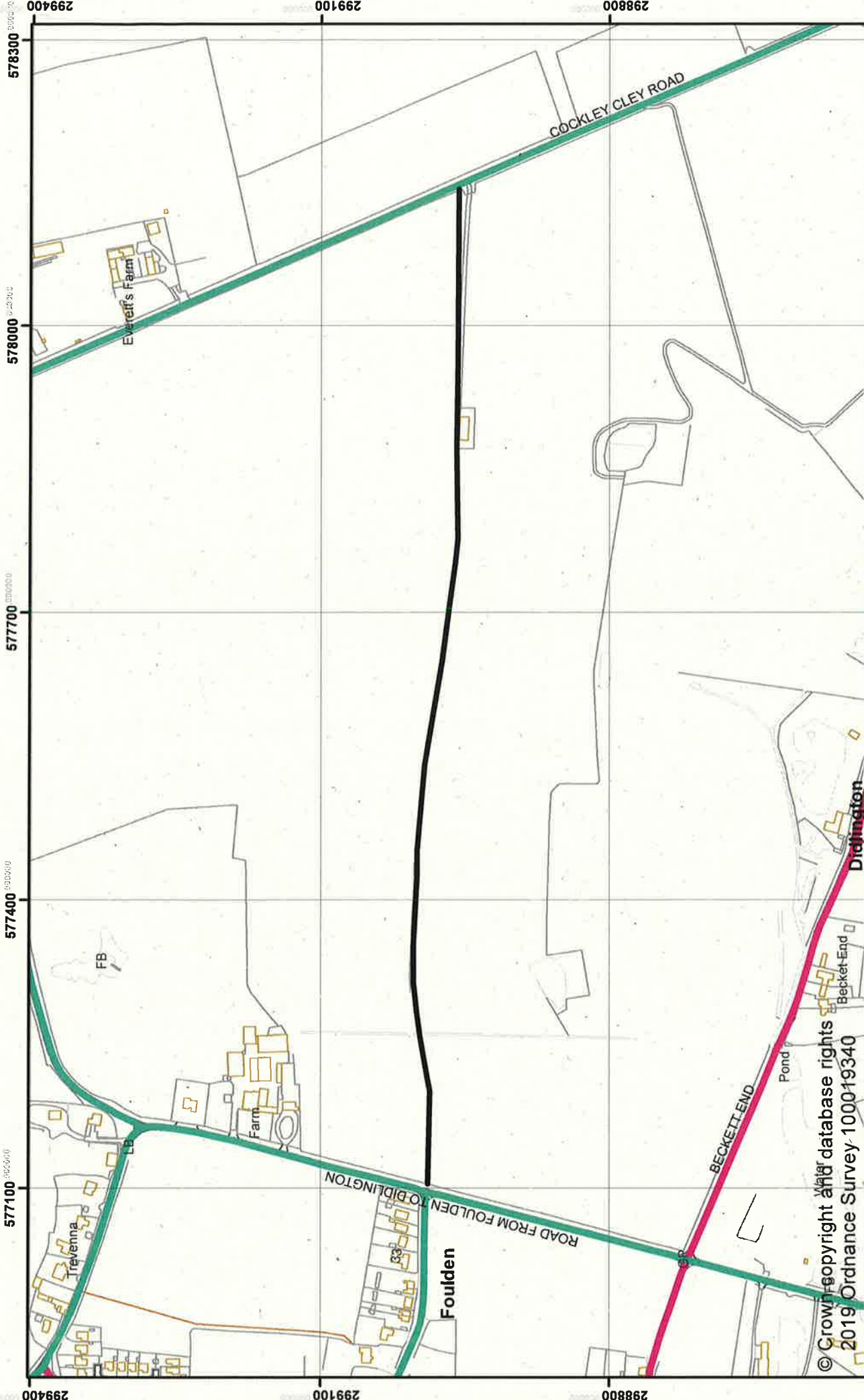


FIGURE 1 ORDNANCE SURVEY 2ND SERIES 25-INCH MAP, MORRIS STREET 70.16 MAP, 1905.
