I, Dr David Ormerod of Mill House, 7 Mill Lane, Swaffham, Norfolk PE37 7EU hereby apply for an order under section 53(2) of the Wildlife and Countryside Act 1981 to modify the definitive map and statement for the area by registering two old public footpaths on the Appleton Estate The highways appear to have been extinguished as a result of the mistaken Sandringham Estate claim of Crown Land status in the mid-20th century.
