

6(1)	"All hedges and trees forming part of the boundary of the Order land or situated within it (unless shown to be removed in the environmental statement or in a landscape and ecological management plan approved under requirement 5) must be protected from any damage during the construction of the authorised development in accordance with BS5837 (2012) 'Trees in relation to design, demolition and construction'."
17(1)	"No part of any numbered work in Schedule 1 (authorised development) is to commence until a written scheme covering the construction of that numbered work for the management and mitigation or emissions from the authorised development of- (i) odour; (ii) artificial light; and (iii) smoke has been submitted to and, following consultation with the relevant district authorities, approved by the relevant planning authority."
22(1)	"No public right of way to be closed or diverted during the construction of or as part of the operation of the authorised development is to be closed or diverted before the relevant local planning authority has given its approval to the details of the relevant closure or diversion."

26 (heading)	"Routeing to Norwich International Airport and Cromer"
Schedule 13 Part 1	Protective provisions – Network Rail
Paragraph 4(6)	"Prior to commencement of construction of the authorised development the undertaker must have obtained the approval of Network Rail to the design, specification, programme of works and method statement for the implementation of any works in respect of the bridge crossing the C874 Plumstead Road, Norwich (approximately 80 metres east of the railway crossing referred to in paragraph 4(5) provided that Network Rail may only approve those aspects of the design and specification that could affect the free, uninterrupted and safe use of any railway of Network Rail or the traffic thereon and the use by passengers of railway property and the undertaker will thereafter comply with the provisions of the approved design, specification, programme of works and method statement."
Paragraph 6(1)	Sub-paragraph numbering to be corrected so as to read "(a)" to "(d)"
Paragraph 9(4)	"If the cost of maintaining, working or renewing railway property is reduced in consequence of any such alterations or additions a capitalised sum representing such saving is to be set off against any sum payable by the undertaker to Network Rail under this paragraph.#"






