I, Dr David Ormerod of Mill House, 7 Mill Lane, Swaffham, Norfolk PE37 7EU hereby apply for an order under section 53(2) of the Wildlife and Countryside Act 1981 to modify the definitive map and statement for the area by registering an old public footpath that for two at least one hundred and fifty years passed between Lynn Road, Hillington and Congham Lodge, but which appears to have been unilaterally extinguished in the mid-20th century.
