
adding the byway open to all traffic from Mill Lane, C 135, at the grid reference TM 0002 9660, in the parish of Rocklands to the metalled C 135 road Mill Lane, at the grid reference TM 0164 9716, in the parish of Great Ellingham

adding to the particulars of the said way by providing that the width is that shown excluded from the hereditaments on the Finance Act 1910 Valuation Plan and that there are no limitations or conditions on the use of the route by the public

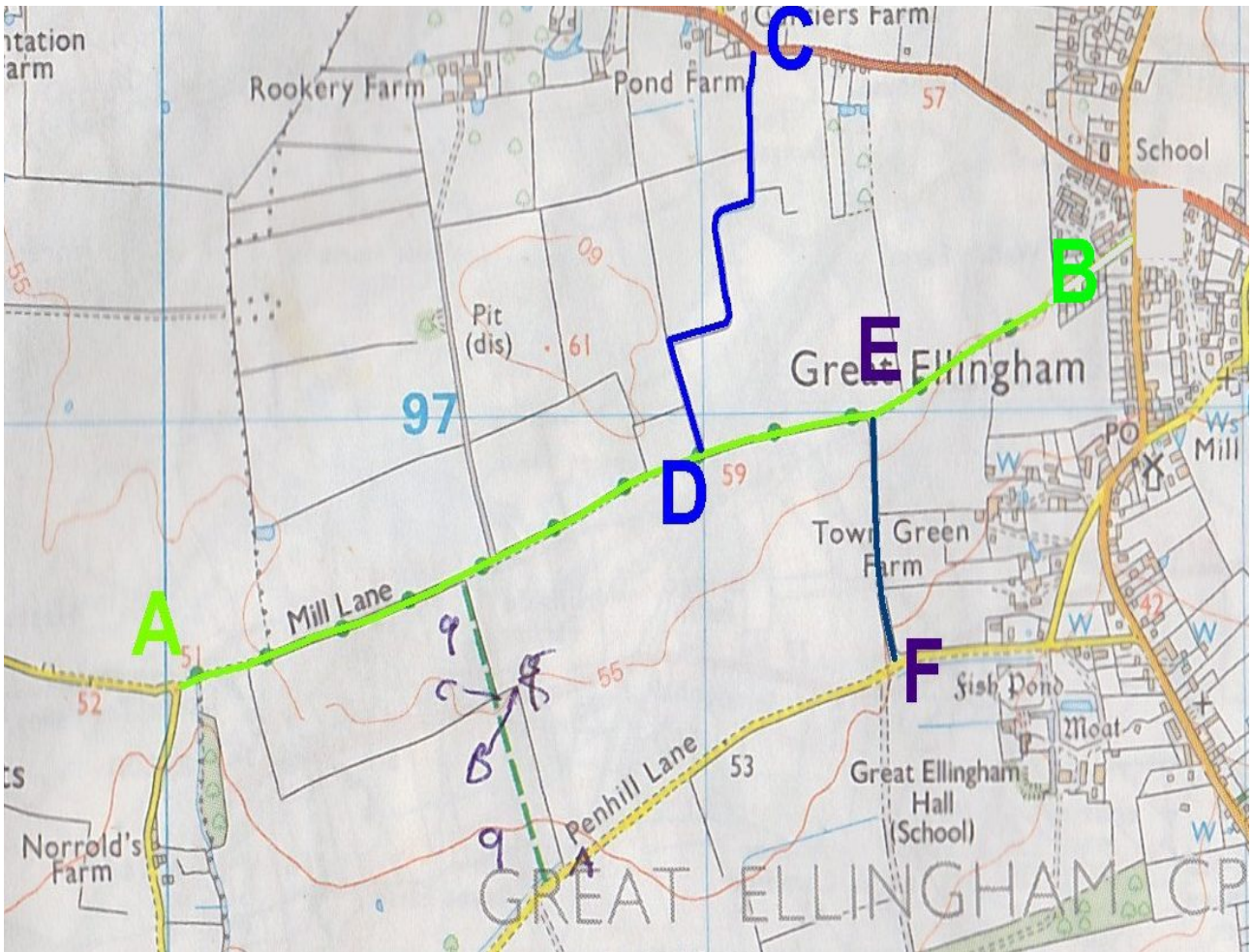
