

# Homes for Ukraine Update 17 – Friday 31 March 2023

Welcome to our latest update for hosts taking part in the Homes for Ukraine scheme in Norfolk.

In this edition there's information about Eurovision Song Contest tickets for Ukrainians, Easter Celebrations and activities. There are also updates on community help sessions and visas.

# Eurovision Song Contest 2023 tickets for displaced people from Ukraine – ballot now open

Ukrainians living in the UK can now apply to enter the ballot for tickets for the Eurovision Song Contest 2023.

The ballot allows individuals on the Homes for Ukraine, Ukraine Family, and Ukraine Extension visa schemes to apply for up to two tickets, as long as the person applying holds a biometric residence permit.

The ballot is open until 4pm on Thursday 6 April. Entries after this date will not be accepted.

The UK Government is subsidising these tickets. If successful in the ballot, individuals will only pay £20 per ticket. This is part of the UK Government's support to ensure the Eurovision Song Contest 2023 is a true collaboration with our Ukrainian friends, and that it celebrates the culture of both countries.

We'd be very grateful if you would share this information with your guests so that people who are eligible know where to apply.

To apply, individuals will need to complete <u>this form</u>, providing their name, email address, and selecting which show or shows they wish to enter the ballot for. They will also need to upload a photo or scan of their biometric residence permit. This is essential to ensure that only those eligible for these tickets are entered into the ballot.

Those successful in the ballot will receive an email confirmation, and will then be able to purchase up to two tickets, at a cost of £20 per ticket. They will need a Ticketmaster account to purchase the tickets. If they do not have a Ticketmaster account already they will be able to set one up ahead of purchase.

For individuals unsuccessful in the ballot, the BBC will be broadcasting the shows, and the Grand Final will be shown live in selected cinemas across the UK. For those who wish to travel to Liverpool, there will be lots of free activities as part of their host city programme.

Anyone travelling to Liverpool will need to arrange their own travel and accommodation.

One of the most frequently asked questions into our Homes for Ukraine scheme inbox are about visas. We often get asked why guest visas take so long and whether there is anything we can do to hurry up the process at all.

We therefore thought it might help to remind you that although we can view the current visa status of guests, visas are managed by the Home Office and unfortunately, we are not able to influence the process. If you do have any questions about visas under the Homes for Ukraine scheme you will need to contact the Home Office Apply for a visa under the Ukraine Sponsorship Scheme (Homes for Ukraine) - GOV.UK (www.gov.uk)
