I, Dr David Ormerod of Mill House, 7 Mill Lane, Swaffham, Norfolk PE37 7EU hereby apply for an order under section 53(2) of the Wildlife and Countryside Act 1981 to modify the definitive map and statement for the area by registering the Grazing Grounds Lane in Bradenham Parish as a Restricted Byway.

This public highway across the Grazing Grounds is divided into three sections: first as a tarmacked highway called Southend between Points A and B. The application road is regarded to start from the end of Southend, coursing between Points B and F, with the start of the compacted stone highway, passing to the south, in Bradenham, and finally with a transit in Saham Toney parish, ending on Mill Lane, Saham Waite.

The highway has a complicated history. Briefly, the highway originally crossed common grazing grounds, but was stopped-off in the Bradenham and Saham Toney Enclosure Awards. The entire route was shown to have been fairly rapidly rededicated to public vehicular use on early and mid-19th-century maps, including a number of Victorian road maps, only for it to become privatized again, apparently following the purchase of much of the Grazing Grounds by WMR Haggard of West Bradenham Hall, the father of Rider Haggard, the novelist, in 1884.

Southend and the Saham Toney sections of the highway have remained public ways. With the significant history of public vehicular dedication, it would require a legally valid stopping-off order, but none has been found. There has since been a variable history of his central section, with the Finance Act IRS DLV maps and National Farm Survey maps, 1943, suggesting that only a central 25% was claimed as privatized - dead-ending two public vehicular highways, the northern and southern components of the Grazing Grounds Lane. I have been unable to determine the nature of this limited exclusion, other than it was owned by one particular Haggard family trust.

Currently, all the highway south of Southend, is claimed as "private," despite these findings. The cumulative evidence suggests that the entire transit of the Grazing Grounds Lane retains a public vehicular right of way. This would be limited to equine usage, for which a restricted byway notation is appropriate. All owners, occupiers, and their 'agents' would have unlimited private vehicular access.


