### 1. Welcome, introductions and Apologies

1.1. All members and officers introduced themselves and apologies were noted (as above).

### 2. Minutes and Matters Arising from Meeting of 25th January 2022

2.1. Previous minutes agreed as accurate.

## 3. Nutrient Neutrality Update – Royal Haskoning

- 3.1. Ian Dennis, from Royal Haskoning, gave the forum a presentation on the latest progress on the Nutrient Neutrality. He set out the legal context of the ruling from the "Dutch case" and Natural England's subsequent stance on this issue which lead to developers must demonstrate nutrient neutrality or provide mitigation to Local Planning Authority confidence that permitting development will not be unlawful against their duty under Habitat Regulations.
- 3.2. Norfolk has 2 internationally protected sites affected by Nutrient Neutrality, namely River Wensum SAC and Norfolk Broads SAC. This is having significant impact on housing developments across the County,
- 3.3. Royal Haskoning has been commissioned to look into the mitigation measures that are needed to fulfil the requirement of Nutrient Neutrality and unlock growth. The current scope of work includes short- and long-term mitigation measures; catchment mapping and Nutrient budget calculator.
- 3.4. The current key task is to develop a nutrient calculator to provide a rapid and quantifiable assessment of nutrient loading from a development. There are similar calculators endorsed by Natural England in other areas and while the exact data to be used is being finalised, this calculator could potentially save millions of pounds in mitigation requirements. Nutrient Budgets will be developed following completion and adoption of the calculator.
- 3.5. Royal Haskoning will also be developing various solutions to offset the effects of nutrient level in the water, these could include wetlands, catchment-based solutions and non-policy measures such as SuDS.
- 3.6. Cllr Fuller emphasised the importance of the Nutrient Calculator and the iterative process of developing the calculator.
- 3.7. Cllr Fuller referenced Court of Appeal ruling on Natural England guidance, that Local Planning Authorities are the responsible bodies to take cogent reasoning based on scientific evidence to make decisions on issue of Nutrient Neutrality when it comes to determining planning applications.
- 3.8. Members debated in detail on the potential risks and benefits of the current emerging approaches including mitigation measures and Nutrient Calculator.

#### 4. GI Rams Update – Trevor Wiggett

- 4.1. Trevor gave the forum an update on the progress of GI Rams. All local authorities have now introduced the tariff for qualifying developments, in 31st March 2022.
- 4.2. In term of governance arrangement of delivering the GI Rams, a steering group has been working on the finer details of the logistical arrangement and finalising on the terms of reference for the overarching board and a job description for the Delivery Officer role.
- 4.3. The brief for the New Rams Mitigation Package review study is being finalised and will be going out to tender.
