Wildlife and Countryside Act 1981 Application for a Definitive Map Modification Order

Registration of the full transit of the trail along the Snettisham (internal) Sea Wall from the north end of the Wolferton Bank to Beach Road, Snettisham Beach. Historically, the sea wall embankments offered the sole available transit north and south through the extensive coastal marshes. The 1953 North Sea flooding at Snettisham was followed by a full-scale re-evaluation of coastal defences. Many of the embankments were re-engineered as stronger, wider and taller structures and concrete enfacement was added to the marine side of many embankments. The Sea Walls have since been denied to the public, even on foot. The trail on the top of the Sea Wall is essentially self-contained, remote, and is external to the RSPB Reserve. The coastal paths in the Reserve and next to the shore are unsuited to additional traffic, but a long distance bridleway could readily be accommodated on the unused Sea Wall. embankment - across the old marshland at height, with the added attraction of a new ornithological vantage point. Ordinances could protect from dogs and nuisances. This is how they were traditionally used.

I, Dr David Ormerod of Mill House, 7 Mill Lane, Swaffham, Norfolk PE37 7EU hereby apply for an order under section 53(2) of the Wildlife and Countryside Act 1981 to modify the Definitive Map and Statement for the area by registering an historical public way that had traditionally exploited the Sea Wall embankments to cross former extensive Sandringham (Wolferton) and Snettisham marshes, passing northwards from the end of the old Sandringham FP1 to Snettisham Beach. The trail was first recorded along the Snettisham Bank in the northern half of the route in an undated 18th-century Map of Heacham and Snettisham. Most of the transit was illustrated as a county road on Faden's Map of Norfolk, 1797, but only on the northern half on the O.S. 1st-series 1-inch map of 1824. The O.S. recorded the entire route on all maps of 1-inch scale or greater from 1884 until after WWII. The coastal littoral was mined for sand, gravel, and carstone close up against this trail from the 1920s to 1962. The embankment construction appeared to be somewhat piecemeal until the southern embankment was consolidated and improved around the turn of the 20th century. Following the re-engineering of the Sea Banks after the 1953 North Sea Snettisham Flood of 1953, and again in 1978, the (internal) Snettisham Sea Wall has been isolated from the general public. The embankment offers a self-contained, long-distance route through some of the most unique countryside, and, in particular, is external to the RSPB Bird Reserve. For most of its length, the embankment is hidden behind trees. Any additional risks to the RSPB Reserve, particularly associated with dogs, could be prevented
