Upgrading Wereham FP1, part of Gibbet Lane, and Wereham FP2 to a Restricted Byway or Bridleway. Starting in what is now the Fincham Village Nature Reserve at TF 68300398, Skinners Lane passes south in Wereham Parish and merges with the southern part of the old Priory Road to join Gibbet Lane, at TF 67980285. This section is currently Wereham FP1. Six hundred yards to the east along the quiet Gibbet Lane, the remaining section of Black Drove continues on south from TL 68560274 as Wereham FP2. A bypass for the Fincham Nature Reserve may have to be found to connect with Wereham FP1 from Black Drove. There is an appropriate area of unfarmed wasteland close by. 
