I, Dr David Ormerod of Mill House, 7 Mill Lane, Swaffham, Norfolk PE37 7EU hereby apply for an order under section 53(2) of the Wildlife and Countryside Act 1981 to modify the definitive map and statement for the area by registering the former public footpaths, Sandringham FP9, FP10, and FP11. These highways, with a number of others, were inappropriately extinguished on the Sandringham Estate during the original deliberations regarding the formation of the Definitive Map in the 1950s. As the N.C.C. Definitive Statement website explains, the Sandringham Estate administration claimed exemption from public rights of way as they were part of the Crown Estate. The Estate is actually a private estate of Her Majesty the Queen, and was not entitled to claim exemption. Almost seventy years later, and neither the Estate nor the Surveying Authority have corrected this error. It is now imperative that these public rights of way are re-established as otherwise they will be lost in perpetuity.

As a number of highways have been improperly extinguished by such means on the Sandringham Estate, the old public rights of way persist. It is apparent that discussions with the Sandringham Estate are urgently necessary to correct this miscarriage of the law by conference in as frictionless a way as possible, rather than leave each way to be argued over individually.
