
adding the byway open to all traffic from a point just to the north-east of 1 Tower Lane, at the grid reference TG 2569 4014, running in a broadly easterly direction as far as the route's physical end, in the parish of Sidestrand, and

adding to the particulars of the said way by providing that the width is that shown excluded from the hereditaments on the Finance Act 1910 Valuation Plan and that there are no limitations or conditions on the use of the route by the public

and shown on the map accompanying this application.

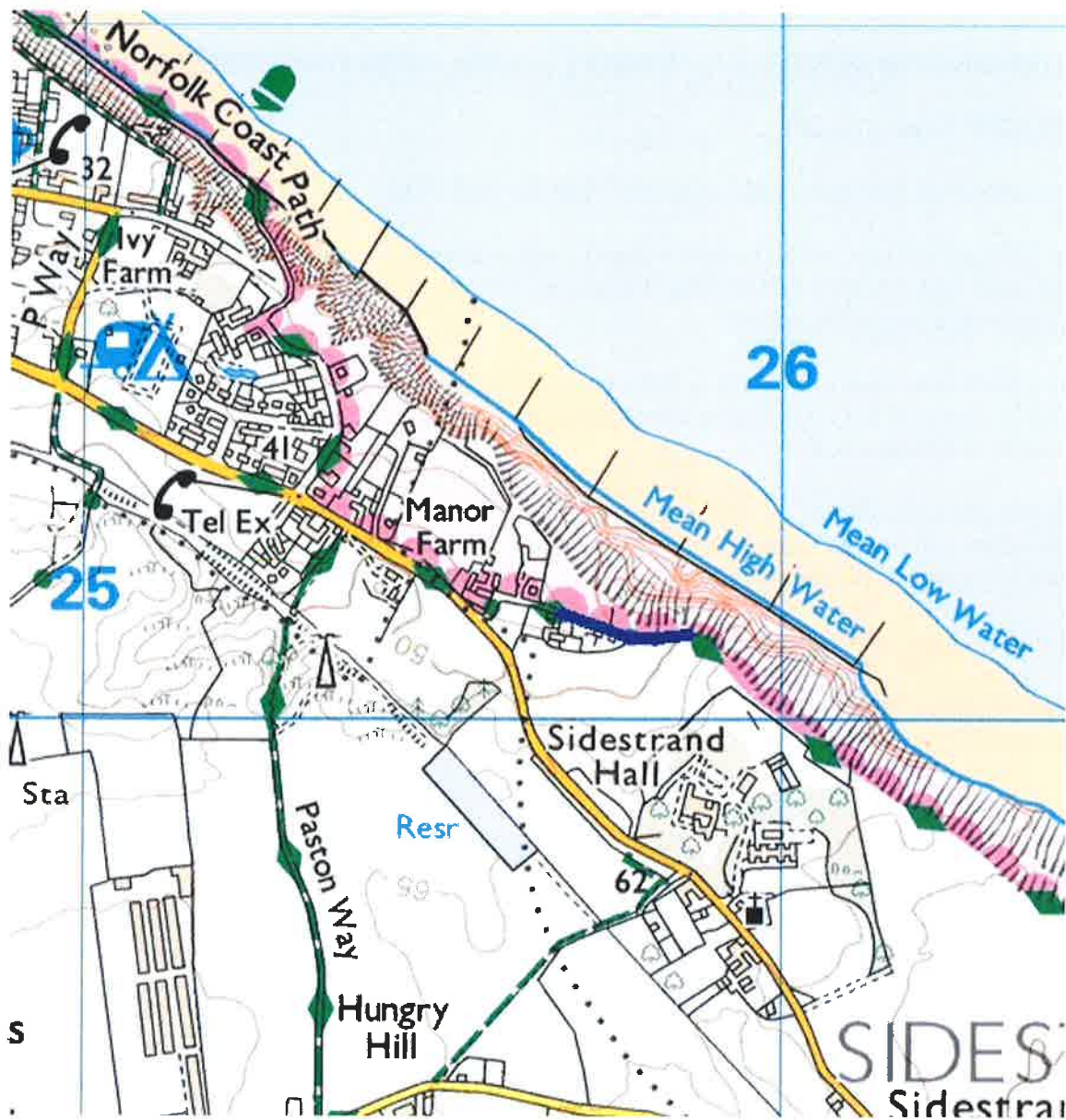
