A.1 Introduction

- A.1.1 Two draft European Protected Species licence applications have been submitted to Natural England, in respect to potential impacts on both bats and great crested newts. These draft licence applications are not included within the Development Consent Order (DCO) that is being sought by Norfolk County Council; they are being applied for in parallel to the DCO process.
- A.1.2 It is not considered necessary to include the extensive documentation submitted in these draft licence applications, as the information duplicates a lot of that in the Bat and Great Crested Newt Survey Technical Appendices, in Volume 2, Chapter 8, Sections D and F respectively. The information in the above reports is sufficient to provide evidence to support the impact assessments in the Environmental Statement.
- A.1.3 Instead, the letters received by NCC from Natural England, confirming receipt of the draft applications and indicating a date by which a response should be expected, are included as evidence of their submission.
