## The Commons Act 2006, application under Section 19 The Commons Registration (England) Regulations 2014. Application to correct the register of common land by the removal of land registered as common at 15 Drabblegate, Aylsham under Unit number CL101

Notice is hereby given that an application has been made by Mr R N Dumolo, Mr J N Dumolo and Mr R W Dumolo to Norfolk County Council as the Commons Registration Authority, to remove a parcel land from the register of common land at No 15 Drabblegate, Aylsham as hatched and edged in red on the plan which accompanies the application and which is attached to this Notice.

A summary of the effect of the application under Section 19 is as described on the application as follows:

- to resolve the discrepancies between the intent of the initial 'Application for the Registration of Land as Common Land' made by the Aylsham Parish Council in 1968 and the subsequent mapping in current registers.
- The application land was excluded from the original application for registration.
   The Commons Registration Authority made a mistake by including it in the provisional application which was then made final
- The extent of common land to the north of 15 Drabblegate identified on the map included with the original application clearly differs from that shown on the register map. The area that was proposed to be registered as common land does not extend to the building.

If the application is granted, in whole or in part, the registration authority will give effect to the determination by removing the land hatched and edged in red on the application plan from the register of common land for CL101 at Drabblegate, Aylsham.


