Definitive Statement of Public Rights of Way for Norwich City

Norwich City

<u>Footpath No . 1 (Eaton)</u> (Wentworth Green) Starts at a point on Wentworth Green adjacent to No. 23 Wentworth Green and the Civil Service Sports Club access road. The path then runs in a south easterly direction passing between the boundaries of domestic properties and a sports ground. The lane is bounded by hedging, closebound and chain link fencing and has a hardened surface of tarmac and chippings. The path terminates at a point adjacent to No. 143 Greenways between the turning points at the ends of Sunningdale and Greenways. The path has an overall length of approximately 370 metres and its width varies between 5.5 and 8 metres.

<u>Bridleway No. 2</u> (Bowthorpe) The bridleway runs from the point where it is joined by Colney Bridleway No. 2 at the mid point of the River Yare at the ford and runs in a northerly direction to the north bank of the River Yare. The bridleway is approximately 5 metres in length. *November 2002*

<u>Bridleway No. 3</u> (Costessey) (Bowthorpe Hall Farm to River Yare) (Officially in SNDC statement) Starts by the side of barn and runs south south eastwards to the north bank of River Yare at Colney.

<u>Footpath No.3</u> (Bowthorpe) (River Yare to Three Score Road) A public footpath not less than 3 metres wide commencing from the north end of City of Norwich (Bowthorpe) Bridleway No. 2 grid reference TG 1792/0796 and running in a generally north northwesterly direction for approximately 390 metres to meet Three Score Road at grid reference TG 1783/0832. *March 2006*

<u>Bridleway No. 4</u> (Railway Line to Parish Boundary) Starts from the southernmost end of Church Lane, north of the railway line (620798/305236) and runs south-eastwards across the railway line by means of a gated level crossing and along the surfaced road to a point adjacent to the entrance to The Cottage (620839/205201). It then continues as a soft earth and grass track in an east-south-easterly direction. The path crosses the River Yare by an old brick arch bridge and ends at the Parish boundary (621072/305150) on the east bank at the western end of Keswick CRF No. 1. The overall length is 295 metres and the width between boundaries is not less than 4 metres. *July 2006*

<u>Footpath No. 5</u> (Bowthorpe) Starts from cycleway 4Y36 off Tippett Close at grid reference TG 1802 0886 and runs in a generally north direction for approximately 12 metres to grid reference TG 1801 0887 at which point the path then turns to run in a north north-westerly direction for approximately 28 metres until it reaches grid reference TG 1800 0889. Up to this point the width of the route is 1 metre. The footpath then turns to run in an east north-easterly direction for approximately 145 metres to grid reference TG 1815 0891 before turning to run in a generally south south-west direction for approximately 216 metres to join an unnamed road located off the roundabout known as Dodderman Way (U45346) at grid reference TG 1813 0870. The width of this section of the route is 6.5 metres. *June 2018*

<u>Footpath No. 6</u> (Sprowston Road to Anthony Drive) Starts at the A1151 Sprowston Road at map reference TG 2386 1090 and runs in a generally south easterly direction between boundary features at a width of 3.7 metres for a distance of approximately 46 metres to map reference TG 2389 1088 where the width of the path reduces to 1 metre and continues in a generally south easterly direction for approximately 16 metres, gradually increasing in width along this length to 1.7 metres, where it meets the U42003 Anthony Drive at map reference TG 2390 1086. *November 2018*
