adding the byway open to all traffic from a point just to the north-west of Northrepps Rectory, on County Road numbered 14376, at the grid reference TG 2480 3855 to the road C292A at Frogshall at the grid reference TG 2537 3810, in the parish of Northrepps

adding to the particulars of the said way by providing that the width is that shown excluded from the hereditaments on the Finance Act 1910 Valuation Plan and that there are no limitations or conditions on the use of the route by the public

and shown on the map accompanying this application.

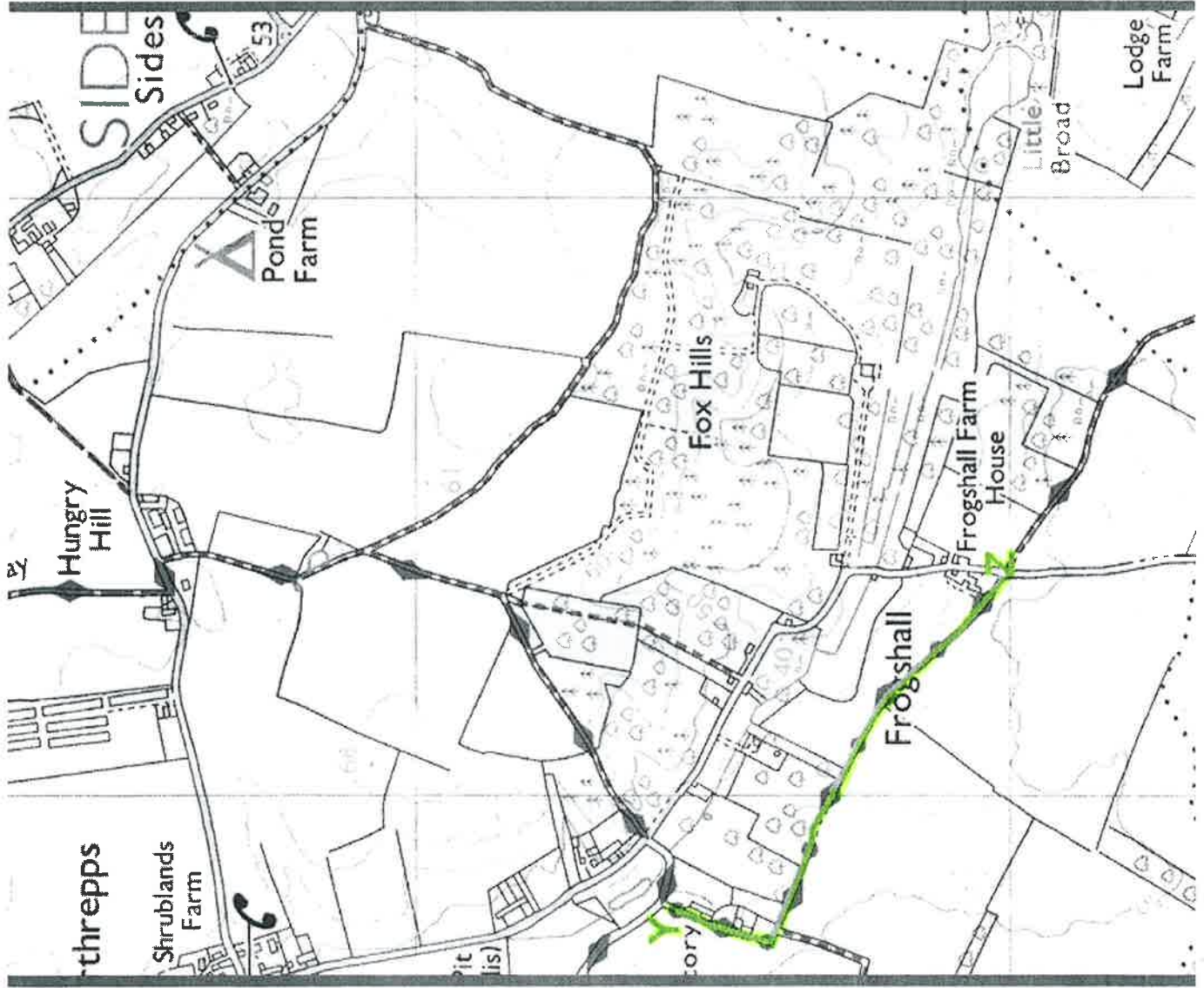
