upgrading to a restricted byway the footpath from the Walcott Service Road at the grid reference TG 3467 3350 to the grid reference TG 3468 3352 in the parish of Bacton, and

adding the restricted byway from the grid reference TG 3468 3352 to the grid reference TG 3473 3351, and the restricted byway from the Walcott Road (B1159) at the grid reference TG 3472 3346 to the sea wall at Watch House Gap, at the grid reference TG 3498 3363 in the parish of Bacton

and shown on the map accompanying this application.

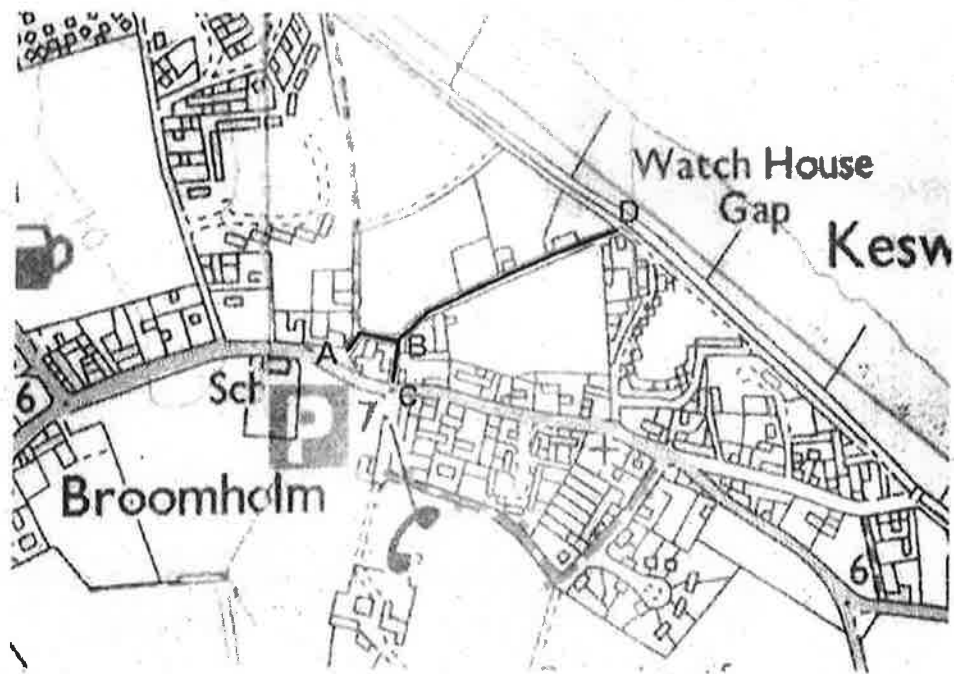
