upgrading to a restricted byway the footpath from the junction of Bradfield Road with Chapel Lane and Wrights Loke to the yard of Warren Farm to join the unclassified road number 19205, and to the Bradfield Road on a bend beside a concrete hardstanding, in the parish of Trunch

and shown on the map accompanying this application.

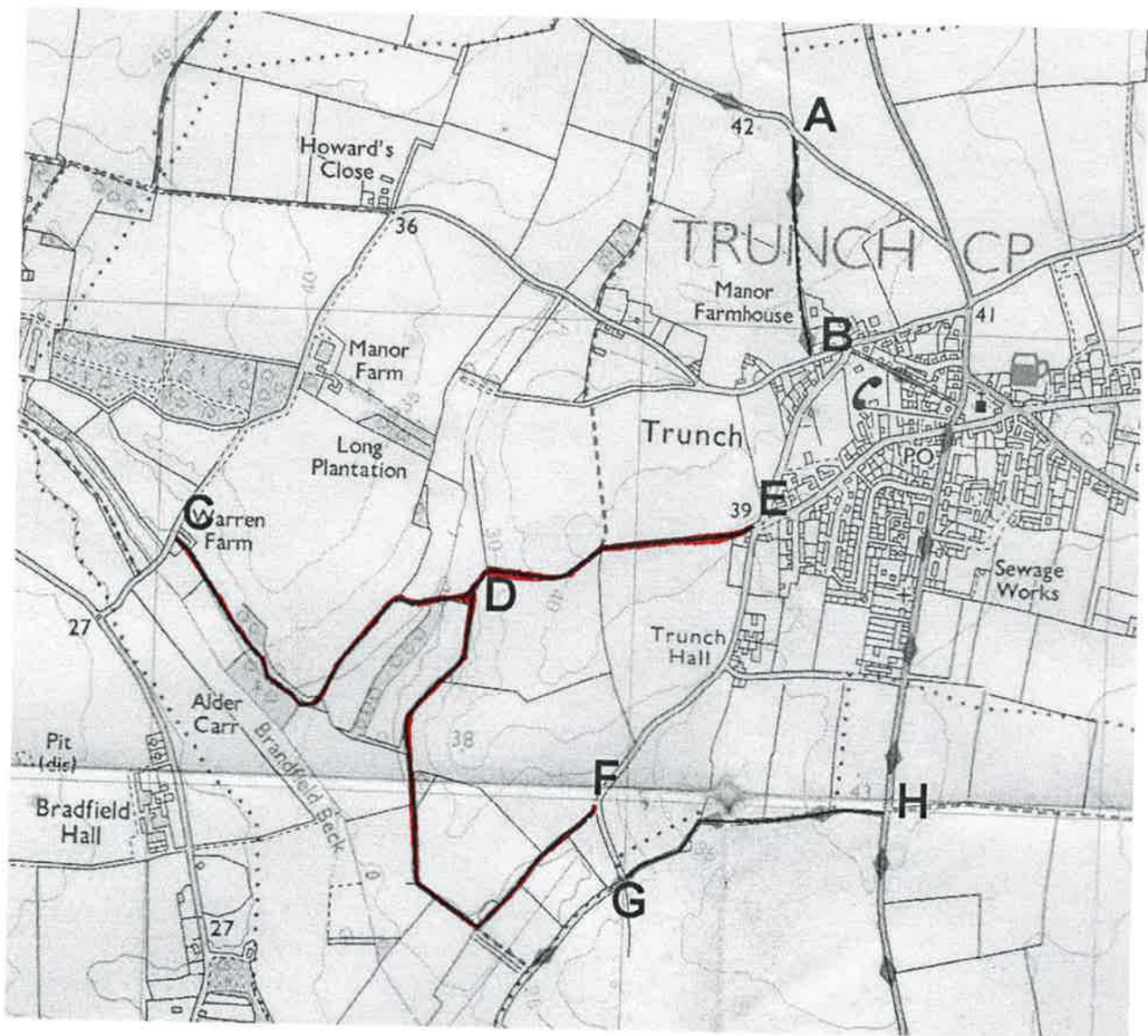
