# **Temporary Traffic Regulation Order 2024**

# Road Traffic Regulation Act 1984, Section 16A, As Amended By The Road Traffic Regulation (Special Events) Act 1994

# Multiple Events during 2024 in the City of Norwich

# **Temporary Restrictions of Traffic Movement**

The Secretary of State for Transport has given his consent to the making of this Order pursuant to Section 16B(6) of the Road Traffic Regulation Act 1984.

Norfolk County Council as the Traffic Authority for the Administrative County of Norfolk makes this Order in exercise of its powers under Section 16A of the RTRA 1984 over an area of the highway being the below-mentioned roads in the City of Norwich to facilitate the staging of various events:

1. The Order shall come into operation on 10<sup>th</sup> May 2024.

## 2. **Definitions**

"Bus" shall have the same meaning as defined in Schedule 1 of The Traffic Signs Regulations and General Directions 2016;

"Civil Enforcement Officer" shall have the same meaning as defined in Section 76 of the Traffic Management Act 2004;

"Cycle" shall have the same meaning as defined in Section 192 of the Road Traffic Act 1988;

"Event" means a parade or activity organised for a special occasion by Norwich City Council and identified in the headings to Article 3 of this Order.

"Taxi" shall have the same meaning as defined in Schedule 1 of the Traffic Signs Regulations and General Directions 2016;

"Taxi Rank" an area of carriageway reserved for use by taxis waiting to pick up passengers as defined in Schedule 1 of the Traffic Signs Regulations and General Directions 2016.

## 3. The Events

#### 3.1 Norfolk and Norwich Festival

3.1.1 This Order has effect between 13:00 and 22:30 on Friday 10th May 2024

(a) While the Order is in operation, traffic over the following roads shall be prohibited only whilst the closures are indicated on site:

Rampant Horse Street from its junction with Westlegate to its junction with All Saints Green; Westlegate from its junction with All Saints Green to its junction with Rampant Horse Street; Red Lion Street from its junction with Westlegate to its junction with Orford Place; Orford Place for its entire length; Brigg Street for its entire length; Haymarket for its entire length; and Gentleman's Walk for its entire length.

(b) While the Order is in operation, traffic over the following roads shall be prohibited and vehicles shall be temporarily prohibited to park, stop or load/unload:

Gaol Hill for its entire length; St Giles Street from its junction with Upper Goat Lane to its junction with Gaol Hill; St Peters Street for its entire length; Bethel Street from its junction with The Forum Car Park entrance to its junction with St Peters Street; Millenium Plain for its entire length; and Hay Hill for its entire length.

(c) While the Order is in operation, vehicles on the following roads shall be temporarily prohibited to park, stop or load/unload (including on existing Taxi Ranks):

Gentleman's Walk for its entire length; and Guildhall Hill for its entire length.

Please note during this closure there will be a relocation of a Taxi Rank to outside the Waffle House on St Giles Street.

3.1.2 This Order has effect between 10:00 and 18:30 on Saturday 11<sup>th</sup> May 2024 and Sunday 12<sup>th</sup> May 2024. While the Order is in operation, traffic over the following roads shall be prohibited and vehicles shall be temporarily prohibited to park, stop or load/unload:

Millenium Plain for its entire length; Bethel Street from its junction with The Forum Car Park entrance to its junction with St Peters Street; St Peters Street for its entire length; St Giles Street from its junction with Upper Goat Lane to its junction with St Peters Street; Gaol Hill for its entire length; Guildhall Hill for its entire length; Exchange Street from its junction with London Street to its junction with Bedford Street; London Street from its junction with Exchange Street to its junction with Castle Street; Gentleman's walk for its entire length; Chantry Road for its entire length; Westlegate for its entire length; All Saint's Green from Westlegate to Surrey Street; St Georges Street for its entire length.

Please note during this closure there will be a relocation of a Taxi Rank to outside the Waffle House on St Giles Street.

#### 3.2 Norwich 100 Cycle Ride

This Order has effect between 05:00 and 11:30 on Sunday 2<sup>nd</sup> June 2024.

(a) While the Order is in operation, traffic over the following roads shall be prohibited and vehicles shall be temporarily prohibited to park, stop or load/unload:

Millenium Plain for its entire length; Bethel Street from its junction with The Forum Car Park to its junction with St Peters Street; and St Peters Street for its entire length.

(b) While the Order is in operation, traffic over the following road shall be subject to a temporary suspension of the one-way system:

Upper Goat Lane for its entire length.

## 3.3 **D-Day Service**

This Order has effect between 09:30 and 12:30 on Thursday 6th June 2024.

(a) While the Order is in operation, traffic over the following road shall be prohibited:

St Peters Street for its entire length.

## 3.4 City Service

This Order has effect between 14:00 and 16:00 on Sunday 9th June 2024.

- (a) While the Order is in operation, traffic over the following roads shall be prohibited only whilst the closures are indicated on site:
- St Peters Street for its entire length; Gaol Hill for its entire length; London Street for its entire length; Bank Plain for its entire length; Queens Street for its entire length; and Tombland for its entire length.

## 3.5 Armed Forces Day

This Order has effect between 09:00 and 12:00 on Monday 24th June 2024

(a) While the Order is in operation, traffic over the following road shall be prohibited:

St Peters Street for its entire length.

#### 3.6 Lord Mayor's Celebrations

- 3.6.1 This order has effect between 22:30 on Friday 12<sup>th</sup> July and 03:00 on Sunday 14<sup>th</sup> July 2024.
- (a) While the Order is in operation, vehicles on the following roads shall be temporarily prohibited to park, stop or load/unload (including all Loading, Car Club, Disabled, Police Vehicle Bays, Residents Permit parking and Motorcycle bays):

Brigg Street for its entire length; Gentleman's Walk for its entire length; St. Peters Street for its entire length; Chapel Field North for its entire length; Chapel Field East for its entire length; Theatre Street for its entire length; Gaol Hill for its entire length; Guildhall Hill for its entire length.

- 3.6.2 This order has effect between 08:00 and 23:59 on Saturday 13th July 2024
- (a) While the Order is in operation, traffic over the following roads shall be prohibited and vehicles shall be temporarily prohibited to park, stop or load/unload (including all Loading, Car Club, Disabled, Police Vehicle Bays, Residents Permit parking and Motorcycle bays):

Theatre Street for its entire length; Rampant Horse Street for its entire length; Gentlemens Walk for its entire length; Orford Place for its entire length; Brigg Street for its entire length; Hay Hill for its entire length; William Booth Street for

its entire length; Haymarket for its entire length; Millenium Plain for its entire length; London Street for its entire length; Caste Street for its entire length; Little London Street for its entire length; Bedford Street for its entire length; Lobster Lane for its entire length; Pottergate from its junction with Upper Goat Lane to its junction with Dove Street; Dove Street for its entire length; St. John Maddermarket for its entire length; Lower Goat Lane for its entire length; Swan Lane for its entire length; White Lion Street for its entire length; Davey Place for its entire length; Old Post Office Court for its entire length; Arcade Street for its entire length.

- 3.6.3 This order has effect between 13:30 and 18:00 on Saturday 13<sup>th</sup> July 2024.
- (a) While the Order is in operation, traffic over the following roads shall be prohibited and vehicles shall be temporarily prohibited to park, stop or load/unload (including all Loading, Car Club, Disabled, Police Vehicle Bays, Residents Permit parking and Motorcycle bays):

Tombland for its entire length; Princes Street for its entire length; Queens Street for its entire length; Upper King Street for its entire length; Bank Plain for its entire length; St. Andrew Street for its entire length; Redwell Street for its entire length; St. Andrew Hill for its entire length; Exchange Street for its entire length; Gaol Hill for its entire length; Guildhall Hill for its entire length.

- 3.6.4 This order has effect between 11:00 and 23:00 on Sunday 14<sup>th</sup> July 2024.
- (a) While the Order is in operation, traffic over the following roads shall be prohibited and vehicles shall be temporarily prohibited to park, stop or load/unload (including all Loading, Car Club, Disabled, Police Vehicle Bays, Residents Permit parking and Motorcycle bays):

Chapel Field North for its entire length; Chapel Field East for its entire length; Coburg Street for its entire length; Chantry Road for its entire length; Hales Court for its entire length; Ninhams Court for its entire length.

- 3.6.5 This order has effect between 07:00 and 19:00 on Sunday 14<sup>th</sup> July 2024
- (a) While the Order is in operation, traffic over the following roads shall be prohibited and vehicles shall be temporarily prohibited to park, stop or load/unload (including all Loading, Car Club, Disabled, Police Vehicle Bays, Residents Permit parking and Motorcycle bays):
- St. Gregory's Green for its entire length; St. John Maddermarket for its entire length; Pottergate from its junction with Lower Goat Lane to its junction with Lobster Lane; Lower Goat Lane for its entire length; Dove Street for its entire length; Lobster Lane for its entire length; St. Benedict's Street for its entire length; Exchange Street for its entire length; and
- (b) While the Order is in operation, the following road shall be subject to a suspension of the one-way system:

Wellington Lane for its entire length.

#### 3.7 Run 10k Norwich

- 3.7.1 This order has effect between 05:00 and 13:00 on Sunday 8<sup>th</sup> September 2024.
- (a) While the Order is in operation, traffic over the following roads shall be prohibited:

Bethel Street from its junction with St Peters Street to its junction with Little Bethel Street; St Peters Street for its entire length; Millennium Plain for its entire length; Rampant Horse Street for its entire length; and Theatre Street for its entire length.

(b) While the Order is in operation, existing restrictions over the following road shall be temporarily suspended:

Exchange Street for its entire length.

Please note during this closure there will be a relocation of a Taxi Rank to outside the Waffle House on St Giles Street.

- 3.7.2 This order has effect between 07:00 and 13:00 on Sunday 8<sup>th</sup> September 2024.
- (a) While the Order is in operation, traffic over the following roads shall be prohibited:

Bethel Street for its entire length; Brigg Street for its entire length; Castle Meadow for its entire length; Castle Street for its entire length; Davey Place for its entire length; Exchange Street from its junction with London Street to its junction with Bedford Street; Gaol Hill for its entire length; Guildhall Hill for its entire length; Ingham Street for its entire length; Little Bethel Street for its entire length; Haymarket for its entire length; Lower Goat Lane for its entire length; Red Lion Street for its entire length; St Stephens Street for its entire length; Red Lion Street for its entire length; Upper Goat Lane for its entire length; White Lion Street for its entire length; and William Booth Street for its entire length.

(b) While the Order is in operation, traffic over the following road shall be subject to a temporary reversal in the direction of the one-way system:

Upper Goat Lane for its entire length.

- (a) While the Order is in operation, traffic over the following roads shall be prohibited:

Abbey Lane for its entire length; Agricultural Hall Plain for its entire length; Alan Road for its entire length; Bank Plain for its entire length; Bank Street for its entire length; Cattle Market Street for its entire length; Chalk Hill Road; for its entire length; Crown Road for its entire length; Exchange Street for its entire length; Ferry Road for its entire length; Greyfriars Road for its entire length; Horbrough Lane for its entire length; King Street for its entire length; Lollards Road for its entire length; Maidstone Road for its entire length; Upper King Street for its entire length; Market Avenue for its entire length; Mountergate for its entire length; Queen Street for its entire length; Rose Lane for its entire length; Redwell Street for its entire length; Riverside (northbound only) from its junction with Station Approach to Prince of Wales Road; Riverside Road (northbound only) from its junction with Prince of Wales Road to its junction with Bishopgate; Riverside

Road (southbound only) from its junction with Rosary Road to its junction with Prince of Wales Road; Sherborne Road for its entire length; St Andrews Street for its entire length; St Anne's Lane for its entire length; St John's Street for its entire length; St Matthews Road for its entire length; and Stuart Road.

- 3.7.4 This order has effect between 08:00 and 10:15 on Sunday 8<sup>th</sup> September 2024.
- (a) While the Order is in operation, traffic over the following roads shall be prohibited:

Chapel Field East for its entire length; Chapel Field Road for its entire length; Chapel Field North for its entire length; Chantry Road for its entire length; Cleveland Road (southbound only) for its entire length; Malthouse Road for its entire length; St Stephens Street from its junction with St Stephens Roundabout to its junction with Surrey Street; Surrey Street from its junction with St Stephens Street to its junction with All Saints Green; All Saints Green from its junction with Surrey Street to its junction with Westlegate; and Westlegate for its entire length.

- 3.7.5 This order has effect between 08:30 and 11:30 on Sunday 8<sup>th</sup> September 2024
- (a) While the Order is in operation, traffic over the following roads shall be prohibited:

Bedding Lane for its entire length; Bishopgate for its entire length; Blackfriars Street for its entire length; Cathedral Close for its entire length; Cathedral Street for its entire length; Cotman Fields for its entire length; Eastbourne Place for its entire length; Elm Hill for its entire length; Fishergate for its entire length; Fye Bridge Street for its entire length; Goldsworths Buildings for its entire length; Magdalen Street for its entire length; Palace Street for its entire length; Pigg Lane for its entire length; Princes Street for its entire length; Quayside for its entire length; Queens Street for its entire length; Recorder Road for its entire length; St Faiths Lane for its entire length; St Martin-At-Palace Plain for its entire length; St Saviours Lane for its entire length; St Vedast Street for its entire length; Prince of Wales Road for its entire length; Stuart Gardens for its entire length; Tombland for its entire length; Upper King Street for its entire length; Waggon and Horses Lane for its entire length; Wensum Street for its entire length; and Whitefriars for its entire length.

- 3.7.6 This order has effect between 08:30 and 11:30 on Sunday 8<sup>th</sup> September 2024.
- (a) While the Order is in operation, traffic over the following roads shall be prohibited:

Canary Fields for its entire length; Carrow Road for its entire length; Geoffrey Watling Way for its entire length; King Street from its junction with Bracondale to its junction with Carrow Road; Koblenz Avenue for its entire length; and Wherry Road for its entire length.

3.7.7 This order has effect between 08:30 and 11:30 on Sunday 8<sup>th</sup> September 2024.

(a) While the Order is in operation, traffic over the following roads shall be prohibited:

Riverside Road (northbound only) from its junction with Thorpe Road to its junction with Bishopgate Road; and Riverside Road (southbound only) from its junction with Rosary Road to its junction with Thorpe Road.

- 3.7.8 This order has effect between 16:00 on Saturday 7<sup>th</sup> September and 12:00 on Sunday 8<sup>th</sup> September 2024.
- (a) While the Order is in operation, vehicles on the following roads shall be temporarily prohibited to park, stop or load/unload (including all Loading, Car Club, Disabled, Police Vehicle Bays, Residents Permit parking and Motorcycle bays unless specified otherwise):

Bethel Street for its entire length; Gaol Hill for its entire length; Riverside Road (pay and display only) for its entire length; Bishopgate for its entire length; and Farmers Avenue for its entire length.

- 3.7.9 This order has effect between 09:00 on Saturday 7<sup>th</sup> September and 12:00 on Sunday 8<sup>th</sup> September 2024.
- (a) While the Order is in operation, vehicles on the following roads shall be temporarily prohibited to park, stop or load/unload:

St Giles Street for its entire length; and St Peters Street for its entire length.

- 3.7.10 This order has effect between 18:00 on Saturday 7<sup>th</sup> September and 12:00 on Sunday 8<sup>th</sup> September 2024.
- (a) While the Order is in operation, vehicles on the following roads shall be temporarily prohibited to park, stop or load/unload:

King Street from its junction with Rose Lane to its junction with Mountergate; Theatre Street for its entire length; Farmers Avenue for its entire length; St Saviours Lane for its entire length; All Saints Green for its entire length; Brigg Street for its entire length; and Gentleman's Walk for its entire length.

- 3.7.11 This order has effect between 18:00 on Saturday 7<sup>th</sup> September and 12:00 on Sunday 8<sup>th</sup> September 2024.
- (a) While the Order is in operation, existing parking restrictions on single yellow lines over the following roads shall be temporarily suspended:

Bishopgate (northside only) outside Great Hospital Gates; Upperking Street (westside only) from its junction with Bank Street to the Bus Stand; Wensum Street (westside only) for its entire length; Magdalen Street (westside only) from Boswell's Yard to 28 Magdalen Street and from Colegate to 8 Magdalen Street.

## 3.8 Battle of Britain

- 3.8.1 This order has effect between 07:00 and 14:00 on Monday 9<sup>th</sup> September 2024.
- (a) While the Order is in operation, traffic over the following roads shall be prohibited:

Bethel Street for its entire length; Gaol Hill for its entire length; Guildhall Hill for its entire length; St Giles Street for its entire length; and St Peters Street for its entire length.

Please note during this closure there will be a relocation of a Taxi Rank to outside the Waffle House on St Giles Street.

- 3.8.2 This order has effect between 22:00 on Sunday 8<sup>th</sup> September and 14:00 on Monday 9<sup>th</sup> September 2024.
- (a) While the Order is in operation, vehicles on the following roads shall be temporarily prohibited to park, stop or load/unload (including motorcycle and loading bays but not including Car Club bays):

St Peters Street for its entire length; Bethel Street from its junction with St Peters Street to its junction with The Forum Car Park entrance; and St Giles Street from its entrance to St Giles Car Park to its junction with St Peters Street.

#### 3.9 Pride Norwich

- 3.9.1 This order has effect between 09:00 and 18:00 on Saturday 27th July 2024.
- (a) While the Order is in operation, traffic over the following roads shall be prohibited and vehicles shall be temporarily prohibited to park, stop or load/unload (including all Loading, Car Club, Disabled, Police Vehicle Bays, Residents Permit parking and Motorcycle bays):

Theatre Street for its entire length; and Rampant Horse Street for its entire length.

Please note during this closure there will be a relocation of a Taxi Rank to outside the Waffle House on St Giles Street.

- 3.9.2 This order has effect between 10:30 and 14:00 on Saturday 27<sup>th</sup> July 2024.
- (a) While the Order is in operation, traffic over the following roads shall be prohibited and vehicles shall be temporarily prohibited to park, stop or load/unload (including all Loading, Car Club, Disabled, Police Vehicle Bays, Residents Permit parking and Motorcycle bays):

Bethel Street from its junction with The Forum Car Park entrance; and St Peters Street for its entire length

(b) While the Order is in operation, existing restrictions over the following road shall be temporarily suspended:

Exchange Street for its entire length.

Please note during this closure there will be a relocation of a Taxi Rank from Gaol Hill to outside the Waffle House on St Giles Street.

- 3.9.3 This order has effect between 12:45 and 14:30 on Saturday 27<sup>th</sup> July 2024.
- (a) While the Order is in operation, traffic over the following roads shall be prohibited and vehicles shall be temporarily prohibited to park, stop or

load/unload (including all Loading, Car Club, Disabled, Police Vehicle Bays, Residents Permit parking and Motorcycle bays):

St Giles Street for its entire length; Gaol Hill for its entire length; Guildhall Hill for its entire length; Exchange Street for its entire length; London Street for its entire length; Little London Street for its entire length; Castle Street for its entire length; Bedford Street for its entire length; Davey Place for its entire length; Gentleman's Walk for its entire length; Haymarket for its entire length; and Brigg Street for its entire length.

(b) While the Order is in operation, traffic over the following road shall be subject to a suspension of the one-way system:

Upper Goat Lane for its entire length.

- 3.9.4 This order has effect between 12:45 and 16:00 on Saturday 27<sup>th</sup> July 2024.
- (a) While the Order is in operation, traffic over the following roads shall be prohibited and vehicles shall be temporarily prohibited to park, stop or load/unload (including all Loading, Car Club, Disabled, Police Vehicle Bays, Residents Permit parking and Motorcycle bays):

Chapel Field North for its entire length; Chapel Field East for its entire length; Chantry Road for its entire length; and Malthouse Road for its entire length.

## 3.10 Galley Hill Dash

This order has effect between 08:00 and 15:00 on Sunday 14th September 2024.

(a) While the Order is in operation, traffic over the following roads shall be prohibited:

Galley Hill for its entire length.

#### 3.11 Remembrance Sunday

- 3.11.1 This order has effect between 07:00 and 12:00 on Sunday 10<sup>th</sup> November 2024.
- (a) While the Order is in operation, traffic over the following roads shall be prohibited:

Bethel Street for its entire length; Gaol Hill for its entire length; Guildhall Hill for its entire length; St Giles Street for its entire length; and St Peters Street for its entire length.

Please note during this closure there will be a relocation of a Taxi Rank to outside the Waffle House on St Giles Street.

- 3.11.2 This order has effect between 11:00 and 12:30 on Sunday 10<sup>th</sup> November 2024.
- (a) While the Order is in operation, traffic over the following roads shall be prohibited:

London Street for its entire length; Opie Street for its entire length; Castle Meadow for its entire length; Agriculture Hall Plain for its entire length; Upper King Street for its entire length; and Tombland for its entire length.

- 3.11.3 This order has effect between 22:00 on Saturday 9<sup>th</sup> November to Sunday 10<sup>th</sup> November 2024.
- (a) While the Order is in operation, vehicles on the following roads shall be temporarily prohibited to park, stop or load/unload (including motorcycle and loading bays but not including Car Club bays):

St Peters Street for its entire length; Bethel Street from its junction with St Peters Street to its junction with The Forum Car Park entrance; London Street for its entire length; Opie Street for its entire length; Gaol Hill for its entire length and St Giles Street from its entrance to St Giles Car Park to its junction with St Peters Street.

## 3.12 **Armistice Day**

This order has effect between 09:30 and 12:30 on Monday 11th November 2024.

(a) While the Order is in operation, traffic over the following roads shall be prohibited:

St Peters Street for its entire length.

## 3.13 Norwich Xmas Lights Switch-on

- 3.13.1 This order has effect between 08:00 and 23:00 on Thursday 14<sup>th</sup> November 2024.
- (a) While the Order is in operation, traffic over the following roads shall be prohibited and vehicles shall be temporarily prohibited to park, stop or load/unload (including all Loading, Car Club, Disabled, Police Vehicle Bays, Residents Permit parking and Motorcycle bays):
- St Peters Street for its entire length; Millenium Plain for its entire length; and Bethel Street from its junction with Forum Car Park entrance to its junction with St Peters Street.
- 3.13.2 This order has effect between 12:00 and 23:00 on Thursday 14<sup>th</sup> November 2024.
- (a) While the Order is in operation, traffic over the following roads shall be prohibited and vehicles shall be temporarily prohibited to park, stop or load/unload (including all Loading, Car Club, Disabled, Police Vehicle Bays, Residents Permit parking and Motorcycle bays):

Brigg Street for its entire length; and Gentleman's Walk for its entire length.

- 3.13.3 This order has effect between 16:00 and 23:00 on Thursday 14<sup>th</sup> November 2024.
- (a) While the Order is in operation, traffic over the following roads shall be prohibited and vehicles shall be temporarily prohibited to park, stop or load/unload (including all Loading, Car Club, Disabled, Police Vehicle Bays, Residents Permit parking and Motorcycle bays):
- St Giles Street for its entire length; Gaol Hill for its entire length; Guildhall Hill for its entire length; Exchange Street for its entire length; Pottergate from its junction

with Upper Goat Lane to its junction with Exchange Street; London Street for its entire length; Little London Street for its entire length; Castle Street for its entire length; Dove Street for its entire length; and St John Maddermarket for its entire length.

(b) While the Order is in operation, traffic over the following road shall be subject to a suspension of the one-way system:

Upper Goat Lane for its entire length.

Please note during this closure there will be a relocation of a Taxi Rank to outside the Waffle House on St Giles Street.

- 4. Nothing in Article 3 of this Order shall apply:
  - a) to anything done with the permission or at the direction of a police constable in uniform;
  - b) to any vehicle being used for police, fire brigade or ambulance purposes, or the purposes of a statutory undertaken in an emergency which necessitates the bringing of vehicles into a section of road to which this Order applies.
- 5. Any existing Orders will become suspended where they conflict with the provisions of this Order during the operation of this Order.
- 6. Alternative routes will be available for use while the Order is in force and shall be signed accordingly onsite. Details and a copy of the plan can be found at <a href="https://one.network">https://one.network</a>.
