

**The Commons Act 2006, application under Section 19(2)(a)
The Commons Registration (England) Regulations 2014.
Notice of an Application for the correction of the Commons
Register for CL109, Castle Acre, Norfolk & CL300, Newton by Castle
Acre, Norfolk.**

Notice is hereby given that an application has been made to Norfolk County Council, the Commons Registration Authority for Norfolk, by Mr M Zipfell under section 19(2)(a) of the Commons Act 2006 and in accordance with the Commons Registration (England) Regulations 2014. The applicant seeks the correction of the commons map and registers for three parcels of land at Emanuel's Common and Mill Common registered under units CL109 & CL300 respectively at Castle Acre and Newton by Castle Acre, Norfolk. The applicant seeks the removal from registration as common of the parcels of land edged and hatched blue on the attached plan. The basis for the application is that these parcels were excluded from the original applications dated 7 February 1968 (CL109) and 27 June 1968 (CL300) for the registration of common land at Castle Acre & Newton by Castle Acre but were mistakenly included by the Commons Registration Authority in the provisional registrations of 19 February 1968 (CL109) and 1 October 1968 (CL300). These provisional registrations, being undisputed, became final on 1 October 1970 (CL109) and 1 August 1972 (CL300).

If the application is granted the Commons Registration Authority will give effect to the determination by removing the land edged and hatched blue from the register of common land.



- must state the grounds on which they are made; and

Any representations made will not be treated as confidential but will be dealt with in accordance with regulation 25. If the application is referred to the Planning Inspectorate for determination in accordance with regulation 26, any representations will be sent with it for consideration. The date on which the period for making representations expires is 31 December 2021.

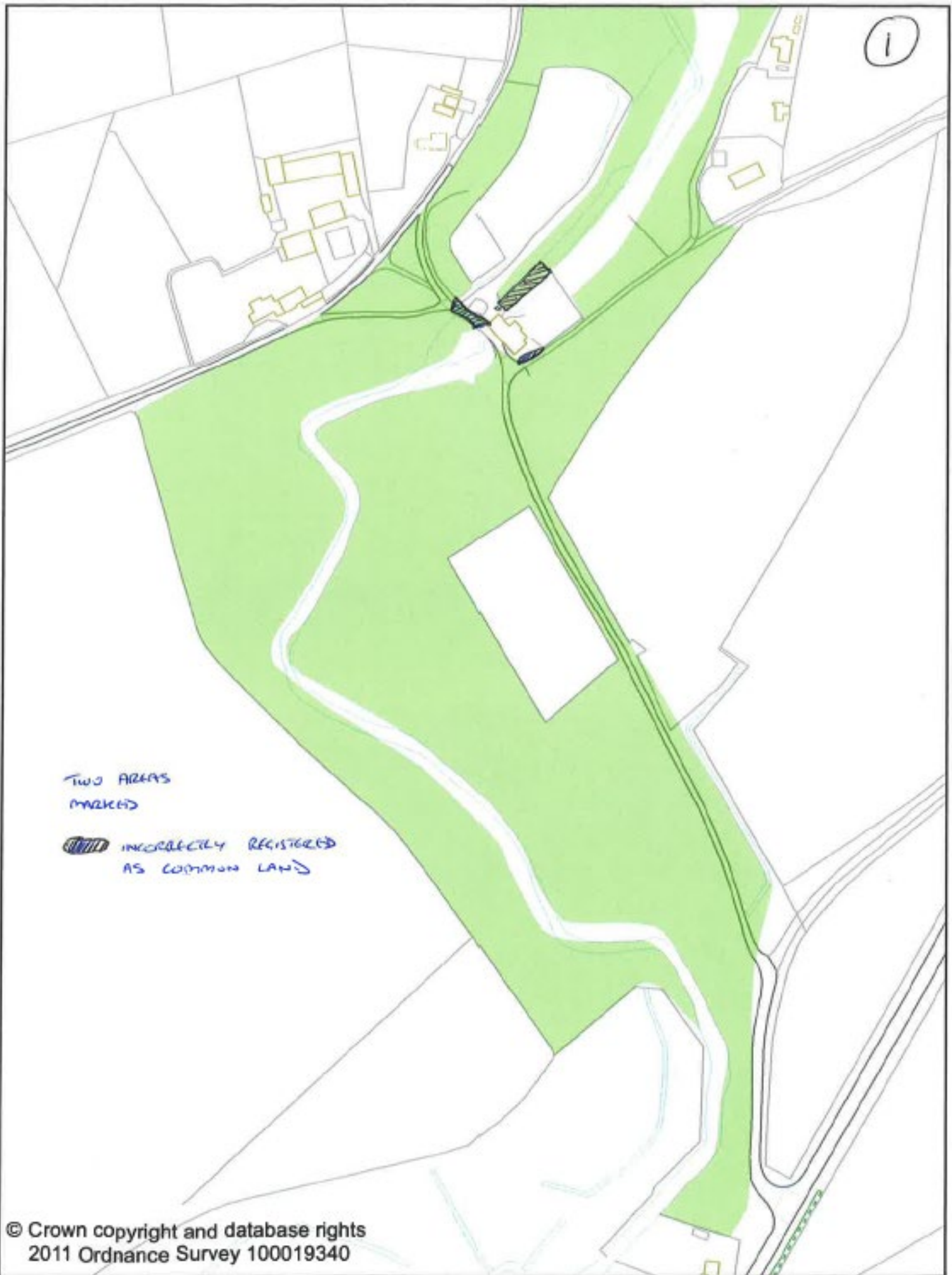
